Sub: Continued Harassment of the absorbed BSNL Pensioners by not issuing revised PPOs in terms of DOT Order allowing fitment benefit by merger of 78.2% IDA for the purpose of fixation of pay/pension with effect from 1.1.2007 to the absorbed BSNL pensioners who retired prior to 10.06.2013 – Case of Controller of Communication Accounts, Kerala

Madam,

We are constrained to again seek your kind intervention in the above matter wherein the CCA, Kerala Circle is taking no action to resolve the issue and release the revised Pension Payment Orders, in terms of the above quoted DOT Order at Ref No. (1), to many BSNL IDA Pensioners (Retired Executives) even though DCO, DOT has forwarded our earlier representation dated 27/11/2017 addressed to you to the Controller of Communication Accounts, Kerala Circle vide No. 6-24/2016/TA-I/PG(PORTAL)/Vol.III/6486-6494 dated 11/12/2017. Even Department of Pension & Pensioners' Welfare had forwarded a copy of our representation to Director (Estt), Department of Telecommunications vide No. 4/5/2017-P&PW(D) dated 07/12/2017 for appropriate action. But there is no positive response even now from the CCA, Kerala and the affected pensioners are continuing to suffer financially and mentally. Such ill-treatment and harassment to the pensioners is really thinkable when the Government has set up several mechanisms to redress the grievances of the pensioners in time.

2. In view of the above, we again earnestly request you to kindly intervene in the matter so

that the CCA, Kerala immediately issues the revised Pension Payment Orders (PPOs) to the affected BSNL IDA Pensioners (Retired Executives).
