Shri A B Murmu, Retd DGM (A/T), Kolkata, who was working as ADG, was transferred to BSNL (HQ) vide DoT No. 12-1/2004-STG.I dated 9/8/2004 and his Last Pay Certificate dated 30/08/2004 was duly issued by Section Officer (Pay Bill), Department of Telecommunications (copy enclosed as Annexure-I).

2. Shri A B Murmu, who was last posted as DGM(A/T), Kolkata, has since retired.
