Sub: Refusal to implement DOT's Order No 2-49(3)/2009-PAT dated 4.11.2010 directing all the Pr. CCAs/CCAs etc to allow pay fixation of the Group B Officers absorbed in BSNL who have opted for IDA pay scale from the date of their promotion after 1.10.2000 – Case of Pr CCA, Kolkata

Sir,

We are constraint to bring to your kind notice that the Principal CCA, Kolkata, which has the dubious record of harassing and depriving the absorbed BSNL pensioners of their dues, is once again financially and mentally torturing the pensioners. Director (TE) of DoT Headquarters had issued an order vide his No 2-49(3)/2009-PAT dated 4.11.2010 directing all the Pr CCAs/CCAs to allow pay fixation of the Group B Officers absorbed in BSNL who had opted for IDA pay scale from the date of their promotion after 1.10.2000. It is regretted to inform you that the Pr CCA, Kolkata is very adamant and refusing to implement the said Order. Earlier, he had not paid full amount of due gratuity and pension to the concerned pensioners. No amount of request and persuasion from the affected individuals and their Association could change his attitude. After having served both the Department of Telecommunication and Bharat Sanchar Nigam Limited for long years, this is the reward that these hapless pensioners are receiving. It may kindly be appreciated that they are not asking for anything extra. They are just asking for their dues as stipulated in Pension Rules and your Office Orders. Having failed to receive any positive response from the Pr CCA, Kolkata, our members have now decided to stage a day-long dharna in protest.

2. We would, therefore, request you to *kindly intervene in the matter. Let the affected pensioners get their dues as per the above stated DOT Office Order dated 4.11.2010. We would also request you to kindly ensure payment of interest against the amount of gratuity and pension that has been unauthorizedly and illegally withheld by the Principal CCA, Kolkata for the last few years.*
