Sub: Transfer of pension related records and Service Books of the retired BSNL Executives with all India transfer liability to the Principal CCA/CCA Office located in the area in which these IDA pensioners are settled – Request for.

Madam,

At the very outset, we welcome the decision of DOT conveyed vide the above referred office letter to collect, complete and keep safe custody of all pension related records of IDA pensioners including their Service Books with Principal CCAs/CCAs.

2. In this context, we also request you to kindly redress a very genuine grievance of the retired BSNL Executives (IDA pensioners) with all India transfer liability. These Officers, when posted outside their home circles, are often required to retire from the office of their last posting. Their pension related papers are accordingly processed by the BSNL Units in which they are posted at the time of their retirement and then sent to the office of Principal CCA/CCA of the area. These Officers, after their retirement, come back to their home station and settle there. But their pension related records, Service Books etc are retained in the BSNL Units in which they were last posted. For any future revision of pension or settlement of any dispute, these IDA pensioners need to interact with these Offices which proves to be difficult and troublesome. Thus their issues remain unresolved for a long period.

3. In order to redress this genuine grievance, we would request that all the pension related records including the Service Books of the IDA pensioners, who had all India transfer liability and retired at a station falling within the jurisdiction of a particular

Principal CCA/CCA, be transferred to the Principal CCA/CCA Office of the area in which these IDA Pensioners have settled after their retirement.
