Sir,

ORDER

Sub: Retirement on Superannuation – Executives belonging to Accounts & Finance Service- regarding.

Shri M. Mathuramani, Sr. Accounts Officer, Staff No. 89209 (HRMS No. 197500045), belonging to Accounts and Finance service of Chennai Telephones, is permitted to retire from BSNL services on attaining the age of superannuation w.e.f. 31.07.2014 A/N.

2. He was permitted to retire on superannuation provisionally on 31.07.2014 A/N vide BSNL CO order No. 14-36/2014-SEA-BSNL dated 31.07.2014 as vigilance status of the executive was withheld vide Vigilance branch, BSNL CO letter No. 22-09/2013-VA/SEA-Ret-VC 2 dated 30.07.2014.

3. Now vigilance clearance in respect of the above executive has been GRANTED by vigilance branch, CO BSNL vide their letter No. 22-11/2019/VC 2/ Retirement settlement dated 01.07.2020 release of final retirement benefits with the note that:
Note: - A prosecution was sanctioned vide file no. 262-38/07-VM-V dt 24.12.2007 and vide judgment no. Spl.CBI cc 11/2013 dated 25.10.2018 "acquitted" but appeal pending in high court DHARWAD KARNATAKA.

4. Regarding release of retirement benefits during pendency of criminal appeal in respect of BSNL absorbed / recruited employees, Estt. Branch has issued guidelines vide their letter no.48-7/2018-Pen (B) dated 30.12.2019. Such order may, however, be subject to the outcome of any Appeal/revision petition filed against the acquittal and the position may be reviewed by the department on the outcome of the Appeal/ Revision Petition. Accordingly, an undertaking may be obtained from the executive before releasing the retirement benefits.

5. As the Vigilance clearance has been granted in respect of Shri M Mathuramani, Sr.AO, his retirement benefits and pension may be regulated in view of para 3 & 4 above and relevant rules on the subject.


5. Government / BSNL dues, if any, outstanding against the executive may be recovered under intimation to this office.
