Sub: Grant of Third and Fourth Time Bound Upgradation of IDA Pay Scales from E-4 to E-5 and E-5 to E-6 IDA pay scales under BSNL Time Bound Promotion Scheme for the Executives – Case of Shri Gurappa S Hugar, Retd AO(L/A), Gulbarga Telecom District, (Staff No. 180467, HR No.198605650).

Sir,

We would like to draw your kind attention to the above-mentioned cases which are pending for a long time. Shri Gurappa S Hugar, who was working as Accounts Officer (L/A) in Gulbarga Telecom District and retired under BSNL VRS-2019 on 31.01.2020, was granted subsequent Time Bound Upgradation of IDA Pay scale from Rs. 24900-50500 (E-3) to Rs. 29100-54500 (E-4) effective from 27.12.2009 vide KTK Circle Office No. FA/Staff/1-48/TBPP/Vol.VII/15 dated 30.01.2020. But his subsequent two consecutive Time Bound Upgradation of IDA pay scales from E-4 (Rs. 29100-54500) to E-5 (Rs. 32900-58000) and E-5 (Rs. 32900-58000) to E-6 (Rs. 36600-62000) are yet to be ordered.

2. We understand that the matter is already under consideration in the Circle Office. However, doubts are being raised about application of the condition for mandatory online examination after issue of Orders granting the benefit in the cases of the retirees.

3. In the above context, we are to submit that on the question of mandatory training followed by examination, BSNL Corporate Office vide its No. 400-29/2007-Pers.I dated 30.05.2007 at Sl. No. 1 of the clarifications issued had clearly clarified that "However, the Executives who have already retired or are retiring within a period of two years from the date of issuance of time bound IDA scale upgradation order, shall be exempted from such training". Moreover, Karnataka Telecom Circle itself in its Order No. FA/Staff/1-48/TBPP/Vol.VII/15 dated 30.01.2020 granting Time Bound Upgradation from Rs. 24900-50500 (E-3) to Rs. 29100-54500 (E-4) to Shri Gurappa S Hugar, Retd AO(L/A) has stated at condition No. 5 of the Order that since the executive is due to retire within a period of two years from the date of issue of this order shall be exempted from the same condition.

4. In view of the above, we feel that there is no other ground to withheld the long awaited two consecutive subsequent Time Bound Upgradation of IDA pay scales from E-4 (Rs. 29100-54500) to E-5 (Rs. 32900-58000) and E-5 (Rs. 32900-58000) to E-6 (Rs. 36600-62000) for Shri Gurappa S Hugar, Retd AO(L/A), Gulbarga Telecom District.

5. Since the pensioner in this case i.e. Shri Gurappa S Hugar, Retd AO(L/A) has already suffered financially and also mentally harassed for years due the Court Case in the Court of 3rd Additional Sessions Judge and Special Judge for Lokayukta & CBI, Dharwad in which he was also finally acquitted of charges along with all others, we shall be extremely thankful if Orders granting his two long pending consecutive subsequent upgradation of IDA pay scales are released at the earliest.
