We are constrained to seek your kind personal intervention in the above case, since no order has yet been issued by Karnataka Telecom Circle granting subsequent Time Bound Upgradation of IDA Pay Scale from E-4 to E5 (Rs. 29100-54500 to Rs. 32900-58000) under the BSNL Time Bound Promotion Scheme to Shri Shrikant B Mohare, Retd Accounts Officer, Gulbarga Telecom District who retired from service on 31.08.2016.

The pensioner i.e. Shri Shrikant B Mohare, Retd Accounts Officer is still facing acute financial constraints and mental harassment, since most of his retiral benefits are yet to be settled, even though he was acquitted of charges along with all other accused in Case No. Spl. CBI 11/2013 in the Court of III Addl. District & Sessions Judge and Special judge for Lokayukt & CBI at Dharwad as back as on 25.10.2018.

In view of the above, we earnestly request you to kindly intervene in this case and cause issue of an early order granting subsequent Time Bound Upgradation of IDA Pay Scale from E-4 to E5 (Rs. 29100-54500 to Rs. 32900-58000) under the BSNL Time Bound Promotion Scheme to Shri Shrikant B Mohare, Retd Accounts Officer, Gulbarga Telecom District.
