Sir,

We are to bring to your kind notice that Karnataka Telecom Circle, following acquittal of charges of all the accused in Case No. Spl. CBI 11/2013 in the Court of III Addl. District & Sessions Judge at Dharwad on 25.10.2018 and thus on conclusion of judicial proceedings, has released the leave encashment of almost all the accused who were once working in Gulbarga Telecom District but retired long back. But it is regretted to state that Shri I. S. Navali, Retd Sr SDE, Gulbarga Telecom District, who retired on 31.05.2012, is yet to receive his leave encashment.

2. It may kindly be appreciated that Shri I. S. Navali, Retd Sr SDE, Gulbarga Telecom District is receiving only his provisional pension, since his final superannuation pension, DCRG and Commuted Value of Pension are yet to be released. Therefore, he is facing acute financial constraints and mental harassment for no fault on his part. Therefore, release of his leave encashment may give him some immediate relief.

3. In view of the above, we earnestly request you to kindly cause issue of orders for immediate release of his leave encashment.
