Sub: Grant of Second financial upgradation from E-3 to E4 pay scale under BSNL Time Bound Promotion Scheme for the Executives — Case of Shri Irappa Somanna Navali, Retd Sr. SDE, Gulbarga TD (HR No. 197306066, PPO No. KTK/CCA/IDA/SA GLB/4622) on his acquittal of charges by the Court of 3<sup>rd</sup> Additional Sessions Judge and Special Judge for Lokayukt & CBI, Dharwad on 25.10.2018.

Sir,

Karnataka Telecom Circle had issued an Order vide No. Staff/3-2/TBP(Ssq.UG)/2009 dated 18.02.2010 promoting 107 Executives of the Circle in the IDA Pay Scale of Rs. 29100-54500 (Second financial upgradation) on completion of their further five years of service on 1.10.2009 after having been granted the first financial upgradation in the IDA Pay Scale of Rs. 24900-50500 on 1.10.2004.

- 2. However, the name of Shri Irappa Somanna Navali, Retd Sr. SDE (HR No. 197306066), Gulbarga Telecom District was found missing in the above stated Order for Second financial upgradation from E-3 to E-4 IDA Pay scale, since a CBI Case (No. Spl CBI CC 11/2013) was pending in the Court of 3<sup>rd</sup> Additional Sessions Judge and Special Judge for Lokayukt & CBI, Dharwad against him and others. But the Hon'ble Trial Court delivered its judgment in the case on 25.10.2018 and acquitted all the accused including Shri I S Navali, Retd Sr. SDE. Moreover, at present there is no stay Order from Higher Court on this judgment and even the Appeal by the CBI is yet to be admitted. As such, Shri I S Navali, Sr SDE, who has already retired from service on 31.05.2012, is eligible to get the benefit of second time bound promotion from E-3 to E-4 IDA Pay Scale w.e.f. 1.10.2009.
- 3. It is unfortunate that though more than one and half years have passed after the Trial Court delivered the judgment on 25.10.2018 acquitting all the accused including Shri I S Navali, Retd Sr SDE in the above stated Court Case, no Order has been issued by the Circle so

far to grant him the Second financial upgradation in the IDA Pay Scale of Rs. 29100-54500 (E-4) which is already over delayed.

4. In view of the above, we request you to kindly intervene in the matter to expedite issue of Orders granting Second Time Bound financial upgradation in E-4 IDA Pay Scale to Shri Irappa Somanna Navali, Retd Sr. SDE, Gulbarga Telecom District.
