**Sub: Endorsement of IDA Orders issued by Dept of Public Enterprises**

Sir,

It has been the normal practice in BSNL to endorse the IDA Orders issued by Department of Public Enterprises from time to time. However, the last IDA Orders issued by DPE vide its F.No. 2(9)/2000-DPE(WC)GL-II/11 dated 17.01.2011 revising the IDA to 141.5% in respect of the PSU Employees whose pay was last revised on 1.1.1997 has not been endorsed by BSNL.

2. Non-endorsement of the IDA Orders applicable to the BSNL Employees of the above said category will invite unintended problems particularly to the Employees who retired prior to 1.1.2007 and opted for the facilities under BSNL Medical Reimbursement Scheme based on their last pay at the time of their retirement, since in their case, as per *BSNL Office Order No. BSNL/Admn.1/14-2/09 dated 8.9.2010*, the above stated set of IDA Orders are only applicable. The field units of BSNL, in absence of any endorsement by BSNL Corporate Office of the IDA Orders issued by DPE, will not act and the pensioners will suffer.

3. We would, therefore, request you to kindly intervene in the matter. Either, let BSNL continue to endorse all the IDA Orders as and when issued by DPE or all the field units of BSNL be advised to download these Orders directly from DPE website in the same manner as the Department of Telecommunication has advised (*vide DOT No. 36-04/2008-Pen (T) dated 24.11.2010*) its all CCAs/Jt CCAs to download the IDA Orders from DPE website for their action instead of waiting for

endorsement by DOT. However, we would request BSNL to go for the second option as it would cut short the delay and also the expenditure on stationery.
