Sir,

In view of Covid-19 pandemic and the risk involved for the aged retired BSNL employees, especially those with chronic health issues and advised to remain indoors, BSNL Corporate had earlier issued Orders extending the validity of BSNLMRS Cards for them to till 30.09.2020. Though unlocking process has now started, the number of positive cases is alarmingly on increase. The restrictions imposed on the aged and those with comorbidities have also not been relaxed.

2. In the background of the above situation, DOP&PW has also issued Orders extending the period of submission of life certificates by the pensioners in Banks for the current year. Now Kerala Telecom Circle has also issued Orders, vide its No.SR/Gen/Union & Assn/10 dated 17.09.2020, extending the validity of BSNLMRS Cards for the retired employees till 31.03.2021 [Copy enclosed].

3. In view of the above and the considering the very genuine problem of the retired employees under the prevailing situation, we request you to kindly cause issue of orders extending the validity of BSNLMRS Cards for the retired employees till 31.03.2021 to be applicable for all the retired BSNL employees.

Sub:- Outdoor Medical Claim for BSNL Retired employees – Clarification Regarding

**Ref:- 1. This Office letter No. BSNL/Admn.1/15-12/18 dated 08.05.2020.
2. This Office letter No. BSNL/Admn.1/15-12 dated 10.06.2020.**

This office issued certain modifications regarding Outdoor Medical Reimbursement to BSNL employees (Serving/Retired) vide this office letter dated 08.05.2020. Subsequently, the cut-off date available to retired BSNL Employees for choosing the options was issued vide this office letter dated 10.06.2020.

Following clarifications are hereby issued for retired employees:-

1. There shall be no cut-off date for switching over to CGHS i.e. retired employee may opt for CGHS Facility at any time.
2. All retired employees need not to give the option. Option is to be exercised by the retired employee only if he wishes to change the mode of reimbursement from with voucher to without voucher.
3. If Retired Employee does not give any option, the mode of reimbursement of his medical bills shall be with voucher.
4. The option may be exercised once in a year. Due to Covid 19 pandemic, the cut-off date for exercising the option is extended up to 30.09.2020 for this FY 2020-21. No further extension shall be given. So the interested retired employees may exercise their option latest by 30.09.2020
5. For subsequent years, the option may be exercised up to the end of Ist quarter i.e. by 30th June every year.
