Sub: Extension of date for revalidation of BSNLMRS Cards for the retired BSNL Employees in view of Lock down in the country as ordered by the Government.

Sir,

We made a representation vide our letter No. AIBSNLREA/CHQ/2020/24 dated 16.04.2020 on the above subject requesting to issue orders extending the revalidation of BSNLMRS Medical Cards for the retired BSNL Employees of the whole country till 30th June, 2020 in the same line as ordered by CBDT (Ministry of Finance) for submission of Form 15-G and Form 15-H on the same ground of lock down ordered by the Government, since the Retired BSNL Employees cannot venture out of their residences during this to visit the virtually deserted BSNL Offices for revalidation work.

But now we find that BSNL Corporate Office has partially addressed our concerns by issuing an Order, as referred to above, but unfortunately restricting its application only for the BSNL Retired Employees of BSNL Corporate Office. As such, the very purpose of issuing the Order is lost. BSNL Corporate Office not only frames policies regarding BSNLMRS but also brings changes in it from time to time and also monitors their implementation. As such, it is the Corporate which alone can decide on the matter of extension of the date for revalidation and also issue orders extending the revalidation work of BSNLMRS Cards for all the Retired Employees stationed all over the country.

3. In view of the above, we earnestly request that BSNL Corporate Office now issue an order making its above quoted Order applicable to all the Retired Employees of BSNL retired from all the BSNL Circles/Units who are also the beneficiaries of BSNLMRS.
