**Sub: Non-issue of final retirement order and consequent non-settlement of pensionary benefits- Case of Shri Dayanidhi Sahoo, Retd CAO (HR No. 197503106) of Odisha Telecom Circle**

**Ref: BSNL CO No. 14-37/2014-SEA-BSNL dated 27.11.2018**

Madam,

We are constrained to seek your intervention in the above matter wherein Shri Dayanidhi, Sahoo, Retd CAO of Odisha Telecom Circle is being denied settlement of his pensionary benefits only because the SEA Section of BSNL Corporate Office is yet to his final retirement Order.

2.1 Shri Dayanidhi, Sahoo, Retd CAO, while working in Odisha Telecom Circle, was issued a charge sheet for major penalty under Rule-36 of BSNL CDA Rule and awarded punishment of 5% cut in pension for a period of one year. On implementation and completion of this penalty, Odisha Telecom Circle, vide its No. VO/Miss-Corr/2009/934 dated 23.07.2018 had requested BSNL Corporate Office to issue final retirement Order of Shri Dayanidhi Sahoo, Retd CAO.

2.2 Thereafter, Odisha Telecom Circle, in response to BSNL Corporate Office letter No. 14-37/2014-SEA-BSNL dated 27.11.2018 (as referred above), had sent all the documents, as asked for, to Shri S D Jhingan, Dy Manager, SEA Section, BSNL Corporate Office vide No. ST/147-83/17/12 dated 06.12.2018. But it is regretted to state that the much-needed final retirement Order of Shri Dayanidhi Sahoo, Retd CAO has not been issued till this day. As a result, the pensionary benefits of Shri Dayanidhi Sahoo, Retd CAO is not being settled.

3. In view of the above, we earnestly request your kind intervention in the matter so that the SEA Section of BSNL Corporate Office issues the much-delayed final retirement Order of Shri Dayanidhi Sahoo, Retd CAO immediately so that his pensionary benefits can be processed and settled.
