Sub: Non-allotment of Fund by DOT to BSNL for payment of balance amount of ex-gratia to the BSNL VRS-2019 retirees.

Sir,

In our earlier representation to you vide our No. AIBSNLREA/CHQ/2020/97 dated 10.09.2020, we brought to your kind notice that as per Cabinet decision circulated by DoT vide its F.No. 20-04/2019-PSU Affairs dated 29.10.2019, it was conveyed at Para 2(iii) of the said Office letter that the Cabinet has decided that "The ex-gratia on VRS is to be paid in two installments of 50% each during FY 2019-20 and during Q1 of FY 2020-21". But the said Cabinet decision was not fully implemented and the BSNL VRS-2019 retirees were yet to receive their full payment.

- 2. Now in reply to our above quoted letter, BSNL has stated in its letter No.32-904/2018-Pen(B) dated 21.12.2020 (Copy enclosed) that <u>"The balance of ex-gratia amount will be paid when funds are provided by DoT, Govt of India".</u> We fail to understand why DOT is not providing the required Fund to BSNL for payment of ex-gratia when the Government had committed to pay the same during Q-1 of FY 2020-21 to the BSNL VRS-retirees.
- 3. In view of the above, we request you to kindly intervene and advise DOT to immediately release the Fund to BSNL to make payment of balance amount of ex-gratia to all BSNL VRS-2019 retirees.
