**Sub: Non-extending the benefit of notional promotion and consequential pensionary benefits in terms of DOP&T OM No. 22011/3/2013-Estt.(D) dated 25.01.2016 - Case of Shri R. R. Garg, Retd JTO, (HRMS 197508955), BSNL, Gujarat Telecom Circle.**

Madam,

We are constrained to seek your kind intervention in a case in which a pensioner Shri R.R.Garg, Retd JTO of BSNL, Gujarat Telecom Circle, who was due for promotion to TES Group B by a duly constituted DPC held in the year 2002 and findings of which was kept in sealed cover, is yet to get his due notional promotion by opening the sealed cover in terms of DOP&T OM No. 22011/3/2013-Estt.(D) dt. 25.01.2016.

2. He was duly considered for promotion by a duly constituted DPC in the year 2002 but his promotion order was not released since the DPC kept his case in a sealed cover because of a pending court case. Subsequently, he was acquitted of all the charges by the CBI Court by an Order passed on 05.04.2016. Following this, the Presidential Order for his absorption in BSNL was issued vide DOT No. GUJ/Bharuch/Group 'B'/2018/36 dated 05.04.2018. Meanwhile, he retired from service on 31.10.2010.

3. Now, as per above quoted DOP&T OM No. 22011/3/2013-Estt.(D) dated 25.01.2016, Shri R R Garg, Retd JTO is entitled to get notional promotion and consequential pensionary benefits. But so far, his individual representations could not evoke response from DOT/BSNL.

4. In view of the above, we seek your kind personal intervention in this case so that justice is bestowed on Shri R.R.Garg, Retd JTO, since absorbed in BSNL, by allowing him notional promotion by opening the sealed cover of the DPC held in the year 2002 as per provisions of the above quoted DOP&T O.M.
