Sub: Refusal by CCA (Nagpur), to issue the equivalent basic pay as per Central Pay scales to the BSNL IDA pensioners desirous to switch over to CGHS.

Sir,

We are constrained to bring to your kind notice that the BSNL IDA pensioners desirous to switch over to CGHS from BSNLMRS, as allowed by DOT, are facing tough time in Maharashtra Circle, since the Controller of Communication Accounts, Nagpur is refusing to issue the equivalent basic pay as per Central Pay Scales in respect of these BSNL IDA pensioners. In this connection, we may point out that DOT vide its OM No. 4-12(11)/2012-PAT(Part) dated 31.08.2016 issued to all the CCAs had ordered that the PPOs issued to the pensioners retiring from Central Civil Estimates will also mention the equivalent basic pay and grade pay as per the Central Pay scales. Subsequently, DOT vide its OM No.4-12(12)/2018-PAT(Part-I) dated 01.07.2019, circulated revised mapping of pay scales from IDA to CDA to all the CCAs.

2. But the Controller of Communication Accounts, Nagpur is refusing to issue the all important equivalent basic pay as per Central Pay Scales to the BSNL IDA pensioners who expressed their willingness to switch over to CGHS from BSNLMRS and as a result the CGHS Office is unable to decide CGHS subscription and ward entitlement. This has put the affected BSNL IDA pensioners in great trouble, since they are unable to get medical attention at their old age when they need it most. It is regretted that hapless BSNL IDA pensioners are being penalized due to the whimsical decision and stand of CCA, Nagpur.

3. In the above background, we earnestly request you to kindly intervene in the matter so that the CCA, Nagpur is advised to follow the office instructions issued from time to time by DOT and also immediately issue the equivalent basic pay as per Central Pay scales to the BSNL IDA pensioners desirous to switch over to CGHS and whose applications are pending with his Office.
