Sir,

We are constrained to seek your kind personal intervention in the above case in which Shri A S Joshi, Retd CAO, BSNL, Maharashtra Telecom Circle, who was awarded penalty of "3% cut in pension for a period of one year" by Director (HR) of Bharat Sanchar Nigam Limited vide BSNL No. VIG/MH-2014/59/ASJ/38 dated 20.06.2017, is still not being paid his regular pension and also his DCRG and Commuted Value of pension not released even though the said punishment awarded in the disciplinary case initiated against him under Rule-61 of BSNL CDA Rules, 2006 has been fully implemented. The Office of Controller of Communication Accounts, Maharashtra Circle of DOT had also confirmed implementation of his punishment from 01.08.2017 to 31.07.2018 in its communication, as referred to at (2) above, addressed to the Asst. General Manager (HR), BSNL, Aurangabad, Maharashtra Telecom Circle.

2. The concerned Pensioner has been pleading with the authorities almost for a year to get his regular pension and also release his gratuity and Commuted Value of Pension, but is receiving no response.
3. In view of the above, we find no other alternative but to approach your kind-self to get the problem of the above-named pensioner resolved at the earliest.
