FOR WHOSE WELFARE?

The ghost “notional” seems to be haunting a few pensioners’ welfare associations of BSNL even today. Perhaps they are so much under the influence of this word that they hardly have any strength to come out of its grip. According to them, the fitment benefit by merger of 50% IDA effectively amounting to 78.2% IDA as on 1.1.2007 for revision of pay scales of the BSNL employees, as per the Presidential Order issued by DOT vide its OM No. 61-01/2012/SU dated 10.6.2013, is only “notional”. This is the view they held ever since the DOT issued its OM dated 10.06.2013. Even though much water has flown through the Ganges during these years and no Order from DOT or BSNL to allow the fitment benefit by merger of 78.2% IDA to the serving employees ever termed the benefit as “notional”, they are still to come out of the grip of the Ghost called “notional”. One such Association has even submitted before PCAT, Delhi that as per the above stated DOT Order dated 10.6.2013, fixation of pay was to be done for all serving employees as on 10.6.2013 notionally from 1.1.2007. The said Association has also submitted to the Tribunal that in accordance with BSNL Orders vide No. 1-50/2008-PAT (BSNL) dated 10.6.2013 for the Executives and No. 1-16/2010-PAT (BSNL) dated 10.6.2013 for non-executives for the purpose of fixation of pay by merging 78.2% IDA fixation was done from 01.1.2007 on “notional” basis. But the fact remains that

neither DPE OM dated 02.04.2009 nor DOT’s OM dated 10.06.2013 nor even BSNL’s Orders dated 10.06.2013 used the term “notional” to allow fitment benefit by merger of 78.2% IDA. If one goes through the pay fixation memos issued by BSNL to its employees, in accordance with these Orders, one would find that nowhere the pay-fixations were declared or treated as “notional”.

We all know that same fitment benefit for pay fixation, which is allowed for serving employees, is also extended to the retired employees for fixation of their pension/family pension. Now as declared by the said Association in the PCAT Delhi, if the pay fixation Orders with fitment benefit by merger of 78.2% IDA for the serving employees is “notional”, quite logically the pension fixation order for the retired employees (pensioners/family pensioners) has also to be “notional”. Thus, indirectly/directly, they have tried to justify the action of DOT in calling the Order dated 18.07.2016 for revision of pension as “notional” and also to establish that there was no discrimination between the serving employees and pensioners in the matter of extending the benefit of pay fixation by merger of 78.2% IDA. This would weaken the case for enhanced pensionary benefits like DCRG, CVP and leave encashment on last pay drawn to the employees (pensioners) who retired after 01.01.2007 and before 10.06.2013. The

submission before PCAT Delhi by the said Association is therefore absurd and ridiculous.

The members of the said Association

which calls itself as a welfare association of the pensioners are now to self-introspect as to whose welfare the said association stands for - welfare of the pensioners or welfare of the Management/Government.

ISSUES TAKEN UP

DELAYED PAYMENT OF QUARTERLY CLAIMS FOR OUTDOOR TREATMENT WITHOUT VOUCHERS TO THE RETIRED BSNL EMPLOYEES – AIBSNLREA TAKES UP THE ISSUE WITH DIRECTOR (HR):

AIBSNLREA has drawn the attention of Director (HR), BSNL regarding the undue delay in making payment of medical claims for outdoor treatment without voucher facility to the retired BSNL employees by the BSNL Units. The Association has submitted that “There had been inordinate delay in clearing the payments for the first and second quarters. Now payment for the third quarters, which is overdue, has not yet been paid by the field units. Again the payment for the fourth instalment is also getting due just after a month. Thus, the retired employees are put into severe difficulties and financial constraints for no fault on their part”. The Association has further requested that “Now that the retired BSNL employees will again have to submit their option for the particular scheme of their choice at the start of coming financial year, we earnestly request you to kindly advise all the BSNL Units to immediately clear payment of earlier quarters and also ensure that the payment of fourth quarter is also not delayed.” [View posting dated 28.02.2018 in this website to read the letter](#)

REMOVAL OF DISCREPANCY/WIDE GAP IN REGARD TO CEILING LIMIT FOR CLAIMS FOR OUTDOOR TREATMENT WITHOUT VOUCHERS– AIBSNLREA TAKES UP THE ISSUE WITH DIRECTOR (HR):

AIBSNLREA points out to the present wide disparity in the ceiling limit for medical claims for outdoor treatment without vouchers between the past pensioners and the new pensioners because of the flaw in the present policy to determine the ceiling limit. The Association has requested to review the present policy to determine outdoor ceiling limit of without voucher facility for the retired employees and remove the existing huge disparity between the past and future pensioners in respect of their ceiling limit. The Association has further requested that the policy be further revised by allowing DA as on 1st April of the year for which claims pertains to be taken into consideration instead of the DA as was available on the date of retirement, at least from the coming financial year. DOT WRITES TO PRINCIPAL CCA, TAMILNADU CIRCLE TO TAKE NECESSARY ACTION ON AIBSNLREA'S REPRESENTATION DATED 10-01-2018 REGARDING VIOLATION OF PENSION RULES: AIBSNLREA had earlier addressed a letter to Secretary (Telecom) on the above issue wherein it was submitted that in violation of Pension Rules, the Principal CCA, Tamilnadu Circle revised the pension of the absorbed BSNL pensioners (executives) which were fixed long back based on their last pay drawn taking into account the pay fixed on local officiating promotion to the DE grade [View posting dated 10.01.2018 in this website]. PMO FORWARDS AIBSNLREA'S REPRESENTATION URGING THE HON'BLE PRIME MINISTER TO INTERVENE IN THE MATTER OF PAYMENT OF PENSION CONTRIBUTION TO DEPARTMENT OF TELECOMMUNICATION IN RESPECT OF PERMANENTLY ABSORBED BSNL AND MTNL EMPLOYEES WHO ARE NO MORE GOVERNMENT EMPLOYEES ON DEPUTATION/FOREIGN SERVICE AS PER SUB-RULE 4 OF RULE 37-A OF CCS (PENSION RULES), 1972: AIBSNLREA had urged Hon'ble Prime Minister of India to intervene in the above matter so that DOT stops collecting pension contribution under FR-116 for the absorbed employees of BSNL and MTNL who are no more on deputation/foreign service after their absorption. The Association also brought to the notice of the Prime Minister that DOT is yet to clear a proposal of BSNL to charge pension contribution on the actual pay of the absorbed employees instead of maximum of the pay scales. The Association further mentioned that DOT has also not implemented a Cabinet decision to charge pension contribution on the actual pay of the absorbed employees of MTNL w.e.f 1.1.2006. BRANCHES IN ACTION

BI-ANNUAL GENERAL BODY MEETING OF AIBSNLREA, EAST VIDARBHA (NAGPUR) BRANCH HELD: The bi-annual General Body Meeting of AIBSNLREA, East Vidarbha (Nagpur) Branch was held on Sunday, the 25th February, 2018 at Amenity Block, CTO Compound Nagpur under the Chairmanship of Shri U B Nikose, President of the Branch. After paying tributes to the departed members/family members, Shri Arun Deshpande, Branch Secretary welcomed all the life members and also the newly enrolled life members. House welcomed Shri S. V Katkar Retired CAO (Pension), Mumbai who shared the Dias as a Special Guest. The Branch Secretary briefed the house regarding the various issues being dealt at local level. He narrated regarding the meetings held with Sr GMTD, CCA and DAP Nagpur for settlement of pending pension revision cases and clearance of medical reimbursement bills.

Shri P R Bhujbal, CHQ Vice President addressed the gathering. He mainly briefed about the efforts to file the Writ Petition by our Association directly in the Honorable Supreme Court of India to get the pay and pension arrears w.e.f 1.1.2007 to the absorbed BSNL pensioners in the matter of fixation of pay/pension/family pension with fitment benefit by merger of 78.2% IDA. After hearing the counsel on 5.2.2018, Leave and liberty was granted by Supreme Court of India, as prayed for by our counsel. As the association now decided to approach the High Court under Article 226 of the constitution of India, it may take some more days to complete the due formalities and file the case. He also made appeal to all left out members who are yet to make contribution, to pay the same at the earliest. Regarding the status of 3rd PRC and pension revision, the members were explained the position in detail. He explained that without pay revision, there cannot be any pension revision as per the law of the land. In spite of the 'affordability' clause in the OM of DPE dated 3.8.2017, the proposal for pay scale revision of the BSNL Executives in the line of 3rd PRC recommendations, duly approved by the BSNL Board, with certain suggestions to meet the additional financial impact, was already sent to DOT for final approval. Some key issues taken up by GS CHQ viz Irrational Payment of Pension Contribution to DOT in respect of permanently absorbed BSNL and MTNL employees under FR-116, and Wrong fixation of Revised pension of the absorbed BSNL pensioners with 78.2% IDA benefit by Few CCA's in BSNL, Review of existing ceiling limit of outdoor medical treatment without Vouchers to the retired BSNL employees and other correspondences made by GS were also explained.

Shri S V Kate Rtd CAO (Pension), Mumbai shared his experience on the incorrect IDA pension revision cases/provisional pension cases under Rule 69 of CCS pension rules(1972) being sent to CCA office by the SSA units. Members of the Branch gave special thanks to Mr S V Kate for his cooperation to association.

S/Shri N G Talewar, State Vice President, B M Mazumdar Finance Secretary, V V Khandve, V W Patil, Vice President, Bhola Kamble, Asst Secretary, M R Sheikh, Bhattacharya took special efforts for the success of the meeting. The meeting concluded after presentation of vote of thanks by Shri N R Rachkondawar, Asst Secretary.

GB MEETING OF AIBSNLREA, AKOLA BRANCH: AIBSNLREA Akola Branch (Maharashtra State) held its General Body meeting on 19th February 2018 at Conference Hall, O/O GM

Telecom, BSNL Akola. Shri N.N. Ambatkar Retd. DE Akola presided over the meeting. 20 members were present in the meeting. Shri A.G. Nema Branch Secretary welcomed all the members present in the meeting. One new member, Shri R.S. Tathod Ex. SDE Buldhana joined as a new member and thus membership of Akola Branch went up to 59. The house welcomed the new member. Branch Secretary apprised about the latest position of 3rd PRC issue. GENERAL BODY MEETING OF SANGRUR BRANCH HELD: A General Body meeting of Sangrur Branch (Punjab State) was held on 16.02.2018 in Kaula Park shop of Shri Parshotam Dass Retd SDE which was chaired by Shri P K Jindal, Retd DGM. The President highlighted the various issues taken up by CHQ with Hon'ble PM, Secretary (T), and Director HR on Pay/Pension revision of BSNL Executives, medical claims for outdoor treatment without voucher and with voucher, opposing DOT's move to pay Pension/ Family Pension by CCAs directly in the Bank Accounts and many other issues. The branch Association members urged for early settlement of Pay revision of BSNL Executives and consequent pension/Family Pension revision, payment of 3rd & 4th installment of fixed Medical Allowance and payment of Medical claims with voucher within one month from the date of submission of bills, as per BSNL Corporate Office instructions issued from time to time, as the members are facing great hardships for their claim settlement due to scarcity of Medical funds from higher Offices. All the members were apprised about our case filed in the Hon'ble Supreme Court and the directions of the Court for granting Leave and Liberty to file the case in High Court under the provision of Article 226 of Constitution of India. The members were advised not to go by any rumours spread by some other Organizations. At the end, last Shri. V K Mittal, Retd AGM gave a presentation on food values of our daily intake by including fruits and raw vegetables in our diets rather going for MRP (Milk and Dairy products), refined products, and packaged foods. He suggested to avoid VIP foods and only to take DIP food (Disciplined and Intelligent) e.g. fruits and raw vegetables. He also explained how to take this DIP food in our Breakfast and Lunch and the quantity to be taken. Vote of thanks was then presented by Shri Gurmail Singh, Branch Secy. The refreshment in the meeting was also provided by him.

GENERAL BODY MEETING OF PALAKKAD BRANCH HELD: A General Body meeting of Palakkad Branch (Kerala State) of AIBSNLREA was conducted at Top in Town auditorium on 12.2.2018. Forty five members attended the meeting and two new Life Members joined the Branch during

the meeting. Members appreciated the efforts taken by CHQ to settle the pension revision with fitment benefit by merger of 78.2% IDA for the left-out cases under CCA, Kerala Circle. Discussions took place regarding the anomaly in the quantum of payment towards medical allowance. Branch Secretary Shri P Prahakaran briefed the status of Court case on pay and pension arrears issue. HALF-YEARLY GENERAL BODY MEETING OF EAST GODAVARI BRANCH HELD: The Half yearly General Body meeting of AIBSNLREA, East Godavari (AP) branch is held on 07.02.2018 in the Conference Hall, Sanchar Bhavan, Rajamahendravaram under the president ship of Shri GV Ramakrishna, President on the chair. Secretary invited the president Sri GV Ramakrishna and Sri Ch Gandhi OS (South) on to the dais. The conference started at 0930 hrs with prayer. 99 members attended the meeting. After the president's opening remarks on the issues of interest, the members introduced themselves to the house. Members discussed mainly about court case on 78.2% IDA balance arrears, denial of the pension benefits of 50% of the emoluments or average emoluments received during last 10 months to the pre 2006 pensioners, 3rd PRC with 15% fitment to pensioners and many other local issues. Four pensioners namely S/Shri Y. Krishna Murty, KV Chalapati Rao, C.Markadeyulu and P. Ramakrishn, who crossed 75 years or going to cross in next six months, were felicitated with presentation of garland Shawl.

Shri GSVSS Vara Prasad DS explained in detail about the court case on 78.2% and explained why Vakalatnama were not taken from all the members and the strategy behind the decision to collected limited number of Vakalatnama from all over India. He explained that we knocked the door of SC under article 32 of constitution. DS also explained the word "Leave and liberty" and about article 226 to move the case to high court. DS also explained about the representations of CHQ submitted to the Hon'ble PM on denial of the pension benefits of 50% of the emoluments or average emoluments received during last 10 months to the pre 2006 pensioners and also the letter addressed on 3rd PRC with 15% fitment formula. Secretary also explained about the letter to PM on the 3rd PRC by the joint forum of working unions and their 5 day Dharna. He also informed the house that he himself had participated in the Dharna for 2 days as a solidarity to the joint forum by the pensioners. He further informed that there is no case pending on 78.2 IDA fitment and payment of arrears from 10.06.2013. Medical bills with vouchers are settled up to December 2017. Two quarters payment is released for the members without vouchers. The balance of two quarters will be released after receiving the necessary approval from Corporate office. DS clarified the doubts raised by the members on the TDS recovery on medical bills with vouchers. He also informed the house that Vasan Eye Care his holding a Free Medical Camp, which is being organized and sponsored by our association, in the Sanchar Bhavan. He requested the members to avail this opportunity. The Branch Secretary stated that the total membership of the Branch 'as on today' i.e. 07.0-2.2018 is 217. In the last six months, 24 new members have joined the branch.

At 1230 hrs, Hon'ble Shri VBS Srneevasa Rao garu, Senior Civil Judge and Secretary, District Legal Services Authority, E G District, who graced the occasion as Guest of Honour, was
