LONG WAIT FOR CLEARANCE OF DRAFT CABINET NOTE ON REVISION OF PENSION WITH REVISED FITMENT BENEFIT

The clearance of draft Cabinet Note for revision of pension of pre-2007 absorbed BSNL pensioners and also those who retired between 01.01.2007 and 09.06.2013 with revised fitment benefit by allowing effective merger of 78.2% IDA is still facing the rough weather from DOT's own Internal Finance Division. We do not find any real ground to justify holding back the file so long except for the callous, indifferent and sadistic attitude of the Officers in Department of Telecommunications dealing with the issue. We are to keep in mind that every aspect of the related issues revolving round the case was critically examined by Department of Telecommunications while finalizing the proposal in consultation with its own Internal Finance. Even the question of annual pension liability of the Government on account of BSNL pensioners limited to 60% of the receipts by the Government from BSNL was duly satisfied. This issue was raised even by Department of expenditure in their letter to DOT seeking clarifications on a few points which they considered relevant while examining the proposal on the subject received from Department of Telecommunication. It is also a fact that Department of Telecommunications replied all the queries including the above to the Department of

Expenditure. In fact, Department of Telecommunications, in their reply, had categorically confirmed that "It is pertinent to mention that 60% cumulative receipt of revenue under specified heads is still higher than the total pension paid by the Government upto 31.03.2013." Department of Expenditure (Ministry of Finance) had accepted this reply from DOT and even cleared the proposal with the approval of Minister of Finance. Thus, there could not be any dispute on this issue at this point of time.

Unfortunately, there are a few great people around us who believe more in circulating stories with apparent intention to create panic rather making strong contribution to help the pensioners. They time and again raise the old issue of pension liability condition on 60:40 ratio between the Government and BSNL finding place in an administrative Order issued by Department of Telecommunication. This is not part of any sub-rule under Rule 37A of CCS (Pension) Rules 1972. Secretary, Department of Telecommunications had even issued clarifications to allay the fears that this has nothing to do with the responsibility of the Government to pay pension to the absorbed BSNL pensioners and under sub-rule 21 of Rule 37A, it is the

Government which is responsible to make payment of pension even if BSNL fails to give the contribution. It is agreed that the decision on the pension liability order is a cabinet decision. But did Cabinet takes decisions without any proposal on the subjects before it? Certainly not. In this case, Department of Telecommunication must have proposed this and cabinet approved it. This does not mean that the cabinet decisions cannot be amended, abrogated. The Cabinet can do that also if any proposal comes before it from the concerned Ministry. In fact giving undue stress on this issue and thus creating confusion, at a time when the draft cabinet note is under finalization, is to indirectly or directly help the administration to sit over the file. This is what is happening in the present case also.

Some people are hoping that the BSNL Unions would be helpful in pushing through the present case of pension revision with revised fitment benefit due to merger of 50% DA effectively amounting to 78.2% in place of 68.8% as ordered earlier. But we do not find any big push from their side. When such an opinion is passed, we understand the responsibility to substantiate that. This can be done subsequently, if required. At this moment, we must concentrate to get the case moved forward. It is still having a long journey to finish before it reaches Cabinet Secretariat. We also know that the present proposal will end its journey after Cabinet approves the same, but our journey will continue even thereafter since the entire matter had a wrong start which would need some operations to get the dues in proper shape.

AIBSNLREA has written to 7th Central Pay Commission that "There are many pensioners who even after completing one full year's complete service on the last day of their service do not get the increment since the date of their annual increment falls on the next day. Just because they retire before the day of receiving the annual increment, even after completing one full year's service, they receive lesser pension and other benefits compared to those who retire after receiving the next increment. Thus an anomalous situation is created in such cases". Citing a Notification issued by Tamilnadu State Government granting notional increment in such cases, AIBSNLREA urges Pay Commission to recommend to allow notional increment in the similar cases for the Central Government Employees also. DEPARTMENT OF PENSION & PENSIONERS' WELFARE ISSUES ORDERS ALLOWING ROUNDING OFF OF A FRACTION OF A RUPEE TO THE NEXT HIGHER RUPEE IN REGULATION OF ADDITIONAL PENSION: Department of Pension & Pensioners' Welfare, vide its OM No. 38/8/15-P&PW(A) dated 16.04.2015, has issued an Order stating that "... The amount of additional pension as finally calculated may be rounded off to the next higher rupee". It also orders that "In cases where pension/family pension of old pensioners has been fixed/revised without rounding off the additional pension, in those cases also, the additional pension be rounded off to the next higher rupee". It may be recalled that it was AIBSNLREA which alone strongly took up the matter with BSNL and then with DOT at the time of revision of pension of pre-2007 BSNL pensioners in 2011 following revision of IDA pay scales for the serving BSNL employees w.e.f. 1.1.2007. BSNL ISSUES ORDER CLARIFYING THAT REIMBURSEMENT OF ALL DIETARY SUPPLEMENTS AS RESTRICTED UNDER CGHS/CS(MA) RULES SHALL ALSO BE RESTRICTED UNDER BSNLMRS: BSNL Corporate Office, vide its Office Order No. BSNL/Admn.I/15-6/14 dated 17.04.2015, has issued a clarification stating that under outdoor medical expenditure reimbursement of all dietary supplements including inadmissible foods, tonics, toiletries and medicines as restricted under CGHS/CS(MA) Rules shall also be restricted under BSNLMRS. This will also speed up commencement of family pension in the event of death of pensioner or spouse." GENERAL BODY MEETING OF AIBSNLREA, WEST BENGAL STATE BRANCH HELD: A General Body meeting of AIBSNLREA, West Bengal State Branch was held at CTO Building, Kolkata on 13th April, 2015 with a mammoth gathering of more than 240 members. After a brief cultural Program, the deliberation started with Shri S.K.Maitra, President in the chair. The House paid its tribute to the departed members and Comrade S.K.Vyas---one of the pioneers of Central Govt. employees' movement. Shri Basu stated that there is no threat perception for BSNL Pensioners even in future and asked them not to panic. He stated that the Orders dated 15.06.2006 on pension liability is an administrative order and not part of Rule 37-A. It is purely an arrangement between DoT and BSNL. This is not a permanent arrangement and may change in future if the DoT decides

so. But in no case, this takes away the responsibility from the Government to pay pension to the absorbed BSNL pensioners. He also discussed about the expectations from VII CPC in regard to the pensioners' issues, Medical facilities to BSNL pensioners and many other issues.
