Kindly find enclosed herewith the correspondence dated 30/01/2020 received from Accounts Officer(Pension) O/o CCA Mumbai wherein it is requested that, if no case is pending, a final retirement order be sent/issued for release of regular pension and pensionary benefits to the retired officer/CAO Shri A. S. Joshi.

In this regard, it is to convey that, a disciplinary case was initiated against Shri A. S. Joshi after his retirement. The inquiry was conducted and he was awarded penalty of 3% reduction in monthly pension for a period of one year vide order cited at sr. no. 1 under reference(copy enclosed). The period/implementation of punishment is over as on 31/07/2018. So there is no disciplinary case pending as of now against Shri A. S. Joshi.

Further, it is to apprise that, vide letter cited at sr. no. 4 & 5 under reference(copy enclosed), the CCA DOT cell is asking this office for furnishing final retirement order for releasing his retirement benefits and whether as on date any other disciplinary proceeding/case is pending against the said retired officer. As on today, there is no disciplinary case pending against Shri A. S. Joshi after conclusion/completion of aforesaid penalty. Hence his vigilance clearance can be issued which is required for final retirement order.

Hence, his case may be examined as per the rules on the subject and the vigilance clearance if justifiable may please be granted so that his pensionary benefits could be settled at an earliest.

Accordingly, the letter dated 30/01/2020 so received from O/o CCA DOT Cell Mumbai is forwarded with recommendation for granting vigilance clearance to said officer which in turn would enable for issuing final retirement order from the end of Circle/Corporate Office as the case be on the basis of which it shall become feasible for CCA to regularize the pension and to release pensionary benefits in favour of said officer in near future.
