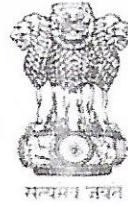

On going through your letter under reference on the subject matter, it is to intimate the incumbent has approached to this office by way of P.G. Portal recently.

In this connection it is further intimated that the official was transferred from Circle during June,2000 to Kolhapur BSNL MH.Circle when there was no procedure to treat the GPF Balance through CCA, DOT and as the balance was supposed to be transferred by way of ATC only. It may kindly be confirmed if any ATC was raised by WTP Circle that time. as to what action was taken by Kolhapur SSA to obtain ATC may be intimated.

Further, as stated by <sup>incumbent</sup> your his balance is not included in final payment made by office. It is therefore intimated that all the ledgers from HRMS only and from ERP system drawn and submitted to this office the case cannot be examined and processed further.
