<b>Grievance Description</b>	
<p>This is a representation from AIBSNLREA addressed to CGMT, BSNL, Karnataka Circle, requesting early settlement of claim for reimbursement of indoor treatment - Case of Shri I F Hadimani, Retd DGM. Shri I F Hadimani, was admitted to Sanjeevini Speciality Hospital, Hubli in an emergency condition, referred to as extensive necrotizing fasciitis of right leg on 19.09.2019 and underwent emergency surgery (debridement) multiple times and subsequent skin grafting. He submitted claim on 5.12.2019, for reimbursement for Indoor treatment in Form -D, along with necessary documents, including the required Certificate for Emergency Admission in non-empanelled hospital Annexure-A. After more than a year, the Karnataka Circle office sent him a letter vide No. WLF/12-52/BSNL MRS/2020/I/34 dated 10.2.2021 asking him to explain the reason for getting admitted in a non-empanelled hospital Annexure-B. Shri I F Hadimani submitted his reply vide his letter dated 31.3.2021 Annexure-C duly explaining the circumstances he had to be admitted in a non-empanelled hospital, mentioning about the Emergency admission certificate issued by the hospital. He had also requested for post-facto approval and early reimbursement of the expenditure citing the financial hardship faced by him. In spite of his repeated attempts, no information about post-facto approval by the CGMT Karnataka Circle is forthcoming, which has left him in unwarranted mental agony. We therefore request you to look in to the matter personally and cause issue of post-facto approval, so that payment can be made as and when funds are available.</p>
