Dear Shri _____,

This is with regard to pending cases of payment of Ex-Gratia in respect of retirees of BSNL VRS-2019 due to pending Vigilance cases. Corporate Office has time and again requested circles to expedite the settlement of pending Vigilance cases. More than 15 months period has passed from the date of voluntary retirement and during this period very few cases of Vigilance matters have been settled.

2. I appreciate the fact that there are certain cases, which are pending before court of law or being dealt by a central or state agency, and we may have limited scope to expedite such cases. However, cases which are under the purview of BSNL authorities, needs to be settled on priority basis in a time bound manner. Even in the cases pending before a court of law or involving other central/state agencies, efforts must be made to expedite the final outcome by pursuing the matter with the concerned agencies / authorities.

3. I would also like to emphasize that the Inquiry report in a disciplinary case is required to be submitted within 6 months and therefore I understand that by now all such disciplinary cases would be in advance stage of finalization. A focused approach is necessary for early settlement of these pending vigilance / disciplinary matters. I may also add that DoT has been pressing hard for issue of Ex-gratia fund utilization certificate from BSNL and the finalization of pending vigilance / disciplinary cases will result in final settlement of Ex-gratia amount from DOT.

4. I, therefore, request you to give your personal attention in the matter so as to ensure that the Vigilance cases of BSNL VRS-2019 retirees are finalized in a time bound manner.
