With reference to the letter under reference on the subject cited above, the brief of the case is furnished below:-

- i. Sh. Channappa M. Urologin (HRMS 198400965) had served in WTP circle, Mumbai from 16.03.1998 to 06.06.2000. He was retired on 30.04.2019 on superannuation.
- ii. This office received GPF final payment application from Accounts officer (Claims), Kolhapur along with GPF ledger extract for the year 2016-17, 2017-18, 2018-19, 2019-20. The final payment has been settled accordingly.
- iii. The GPF subscriber and BSNL Association lodged many grievances in PG portal & via email that the GPF balance of Rs. 132440/- was not transferred to Kolhapur.
- iv. The AO (Pay), Kolhapur confirmed via email on 26.03.2021 that the balance of Rs. 132440/- for the period from 16.03.2019 to 06.06.2000 was not incorporated in Kolhapur accounts.
- v. while scrutiny of the GPF balance sheets provided by the GPF subscriber / BSNL association, it is observed that interest has been calculated wrongly

vi. It is observed in the BSNL GPF ledger for the FY 2007-08 Opening balance taken Rs. 10000/- and closing balance of Rs. 96280/- and Opening Balance for the year 2008-09 Rs. 496115/-

In view of the above, it is requested to take up the matter with WTP circle and submit the residual payment to this office at earliest.

Further, it is requested to forward all the GPF Ledgers from 01.04.1998 to 30.04.2019.
