**OFFICE MEMORANDUM**

**Subject:- Board level and below Board level posts including non-unionised supervisors in Central Public Sector Enterprises (CPSEs) at 1987, 1992, 1997 and 2007 levels - Payment of IDA at revised rates-regarding.**


The undersigned is directed to refer this Department's O.M. of even number dated 18.01.2012 (for 1987 and 1992 IDA rates), O.Ms. No.2(9)/2000-DPE(WC) (1997 IDA rates ) dated 18.01.2012 and O.M. No.2(70)/2008-DPE(WC) (2007 IDA rates) dated 16.01.2012, providing the rates of DA effective from 01.01.2012 on the subject quoted above.

2. The figures of AICPI for the months of December, 2011 to February, 2012 are as follows:

3. The D.A. rates effective for each quarter at 1987, 1992, 1997 and 2007 level are also being released based on the same quarterly average. As seen from above table, there is no change in the quarterly average as calculated above on 1960=100 and 2001=100 and quarterly average earlier calculated for the D.A. increase effective from 01.01.2012. Since there will be no change in the existing DA rates, the status quo of the existing DA rates for 1987, 1992, 1997 and 2007 pay scales would be maintained for a further period of 3 months effective from 01.04.2012.

4. All administrative Ministries/ Departments of the Government of India are requested to bring the foregoing to the notice of the CPSEs under their administrative control for action at their end.
