<b>Grievance Description</b>	
<p>This representation is addressed to the Principal General Manager (Pers) BSNL, regarding Non-settlement of the case for issue of final superannuation pension, release of DCRG and grant of Commuted Value of Pension even after completion of judicial proceedings on 25.10.2018 to a pensioner retired on 31.12.2010 Case of Shri G P Biradar, Retd DE, Bangalore Telecom District of Karnataka Telecom Circle. This is in continuation of our prolonged effort to get a long pending issue resolved. The issue relates to issue of final superannuation pension, release of leave encashment, DCRG, Commuted Value of Pension etc for Shri G P Biradar, Retd DE, Bangalore Telecom District (Karnataka Telecom Circle). The affected pensioner was acquitted, along with others, of all charges by the designated Court at Dharwad on 25.10.2018 and at present no other case is pending against him. His case is similar to that of another pensioner Shri S B Mohare, Retd AO, Karnataka Circle, who was also listed as accused in the same case but was acquitted of charges and for whom BSNL Corporate Office, vide is No. BSNL-CO-PRII/11(12)/1/2020-PERS-II dated 21.07.2020, has already issued Orders allowing him to retire and receive all pensionary benefits. Shri G P Biradar, Retd DE, is yet to receive his final superannuation pension and other benefits.2.After our continuous persuasion and in response to our grievance filed with DoPPW vide Docket No. DOPPW/E/2020/15400, CGMT Karnataka Circle, on 23.12.2020 had closed the docket stating that the officer retired on 31-12-2010. He has requested for final superannuation pension, release of leave encashment, DCRG commuted value of pension. At the time of retirement, a CBI court case was pending against him. He has been exonerated by the designated court at Dharwad. To meet the above demands, VC is required. Action for seeking VC is under process. On receipt VC, all eligible payments will be made. Annexure-A3.Later, Karnataka Circle vide its letter No.Staff/91/Retirement/2021/5 dated 02.06.2021 had sent the Vigilance status of Shri G P Biradar, for issuing final retirement, in response to an email dated 31.05.2021 from AGM Pers-I, BSNL Corporate Office Annexure-B. It appears that the matter is pending with Personnel Section of Corporate Office till now.4.We therefore request you to kindly cause issue of final retirement order in respect of Shri G P Biradar, Retd DE, Bangalore Telecom District, without further delay, so that the agony of the retired executive comes to an end.</p>
