With reference to the letter under ref.1 of GS, AIBSNLREA to Secretary (Pension), Dept of Pension & Pensioners' welfare

The following points are furnished for your consideration

It is constrained to note that BSNL Tamilnadu Circle office is being accused of being reluctant which is far from facts. As Shri Velappan is fully aware that the issue was raised with BSNL TN circle office only after a lapse of 25 years, the issue related to DOT period during which the employee worked in MTNL and has stated that MTNL south has remitted the GPF contribution to Coimbatore SSA. The Representation received from Shri V.Velappan was duly forwarded to Coimbatore SSA for verification and compliance as the officer was working at Coimbatore at that particular period and the GPF records were maintained at SSA Level. The representation was also forwarded to Accounts Officer MTNL Mumbai for verification and furnishing of details.

In this regard it is submitted that MTNL has not furnished payment particulars till date and reply of Coimbatore SSA was received vide No.CA/CBE/GPF/VV/206-17/7 dated 14.07.2017

Regarding missing credit of GPF a detailed reply was given vide No.TAC/GPF/Genl-correspondence/2011-12/Vol.II/142 dated 08.09.2015

Based on the reply received from CAO (Estt) Coimbatore a detailed reply for PG case DOTEL/E/2018/11977 was furnished vide No.TAC/TAX/BSNL/GPF/Genl Corr/2016-17/22 dated 18-06-2018

Further a detailed reply was also given for PG No-PMOPG/D/2020/0068622 raised by Shri V.Velappan vide Lt.No.TAC/GPF/Genl.Corr/2014-17/25 dated 21/09/2020

Neither the Department nor the pensioner is held responsible for the fire accident that happened during 1998. It is learned that after the fire accident all the employees of the department were asked to provide the available records of their own for reconstruction of the destroyed Service book and records. It is not known whether the pensioner has submitted any such document or records at that time to Coimbatore SSA.

Non receipt of GPF Balance sheet for the years 1986-87 and 1987-88 should have been taken up at that time itself by the officer. It is the responsibility of every employee to take up the case within reasonable time to get Balance sheet and corrected their records. (Almost 10 years were available to sort out the issue from 1988 to 1998 when Fire accident occurred)

As at this distance date without any reply or proof from Coimbatore SSA and MTNL Mumbai, BSNL Tamilnadu circle is not in a position to intimate the proof to Department of Telecommunication (DoT). Hence it is requested to inform the same to the Association accordingly.
