Extension of empanelment of hospitals in Nagpur SSA.

Ref: CGMT BSNL MH Circle Mumbai No. A/A-II/Med. Faci/Nagpur/2014/2 dated 16-01-2015.

As per approval conveyed vide above cited letter on the subject and in accordance with the MoU, the 17 Hospitals in Nagpur SSA as shown in the enclosed 'Annexure' are empanelled under BSNL MRS Scheme, for the in-door medical treatment to the BSNL employees as well as to the retired BSNL employees of Nagpur SSA and their dependents, for the period of two years as shown against each.

As such, the in-door medical treatment at above hospitals is entitled for authorization under BSNL MRS Scheme. It is therefore requested to bring to the notice of all the employees working under your kind control as well as to the retired employees, that the in-door medical treatment may be availed at the above hospitals till the period of their validity. The Unit Officers shall also issue In-Door Medical Treatment Authorization Letter under BSNL MRS Scheme for the same. And vide publicity to this may be give amongst the employees.

Note : The Retired officials should contact SDE (Welfare) on his Office Tel. No. 2531942 or Mobile No. 9422812118 and the working staff should collect the Authorization Memo from their respective Controlling Officer, prior to admission to above Hospitals. It may also please be noted that normal stay for in-door treatment is only for 10 days. In the event of further stay in hospital, an intimation thereof will be given to the Controlling Authority by the hospital, justifying the extension of stay in hospital beyond 10 days. Before issuing 2nd Authorization Letter, the Controlling Officer shall obtain approval from the Head of SSA w.r.t. intimation received from hospital justifying the further hospitalization stay beyond 10 days. The 2nd letter of Authorization for further period (i.e. beyond initial 10 days) will have to be issued by the next higher authority to the 1st issuing authority. The 2nd Visit Report will also be issued by the authority issuing 2nd Authorization Letter. For more details please refer the circulars on BSNL intranet on Internet.
