We would like to invite your kind attention to the above and say that in the last meeting of SCOVA held in February 2014, two important issues pertaining to the Department of Telecommunications were discussed. The relevant extract of the minutes is reproduced below:

2. We now like to submit that none of the above two issues have so far been settled. In fact, nothing is known about implementation of the decisions taken in the said meeting on those two issues. In respect of the first item i.e. SI No 4 of the ATR, Department of Pension & Pensioners' Welfare had to send their response to DoT after examining the proposal received from Department of Telecommunication. But nothing is known in this respect. In the second case (SI no. 5 of the ATR), Department of Telecommunication has not settled this long pending issue.

3. In view of the above, we shall request you to kindly get the said two old items reviewed in the forthcoming meeting and settle the same.
