We hereby draw your kind attention to the delay in sanction and payment of Family Pension to Smt.Sadhana Arjun Davange, wife of Shri Arjun Mahadu Davange, Retd DGM O/o the CGM WTR, who had expired on 16.06.2024.

2. Smt. Sadhana Arjun Davange, having joint account in the pension drawing bank with Shri Arjun Mahadu Davange, had intimated about his demise on 01.07.2024 and had submitted the Death Certificate on 27.07.2024. She had submitted the request for sanction and payment of Family pension on 16.08.2024 along with all required documents. [Copy enclosed] But the family pension is yet to be sanctioned and paid by CCA Maharashtra & Goa, although pension has been stopped for July 2024 following intimation about the demise of the pensioner. Smt. Sadhana Arjun Davange is experiencing financial hardship due to non-receipt of family pension since July 2024.

3. We would request you to kindly ensure that family pension is sanctioned and paid to

her immediately, as there is no justification in delaying it when she is having joint account with the deceased pensioner and had promptly submitted all required documents.
