Sir,

We hereby draw your kind attention to non-payment of pension for August 2023 subsequent to transfer from CCA Maharashtra & Goa to CCA, Madhya Pradesh in respect of Shri Diwakar Kotwal, Retd SDE WTR Bhopal, PPO No. 40201311215793.

2. Shri Diwakar Kotwal, Retd SDE WTR Bhopal was getting his pension disbursed by CCA MH & Goa, since he had worked in WTR. Owing to difficulties experienced in some issues, he had sought for transfer of his pension from CCA MH & Goa to CCA, Madhya Pradesh and also got his pension disbursement transferred on 10<sup>th</sup> August 2023. But he has not received his pension for the month of August 2023.

3. He sent an email to both CCA Maharashtra & Goa and CCA Madhya Pradesh and also informed through SMS and WhatsApp. With no response to his submissions, he submitted a grievance about non-payment of his pension through SAMPANN vide Ticket No.

2023090763219 requesting early payment of pension for August 2023. But to his surprise, the grievance has been forwarded to WTR, BSNL, Bhopal, which has nothing to do with this matter. Already aggrieved with non-receipt of pension, he feels let down and annoyed over the issue.

4. We shall be thankful if urgent attention is given to this issue and appropriate direction is given to CCA Madhya Pradesh for immediate release of his pension for August 2023.
