Sub: Enormous delay in issue of IDA CDA mapping certificate for the purpose of deciding monthly contribution for availing CGHS facility by BSNL absorbed pensioners - request for automating the process

Sir,

This is w.r.t our letter cited above wherein we had pointed out enormous delay in issue of IDA-CDA mapping certificate and in order to avoid the delay we had suggested that "As the SAMPANN has data of the IDA pay scale, the basic pay at the time of retirement and the grade in which a pensioner has retired, there should not be any difficulty to insert a programme to match these with the corresponding CDA pay scale and creation of the mapping certificate, which can be downloaded by the pensioner from the SAMPANN portal, of course after due authentication through OTP."

2. In response to the above letter, we were informed vide your letter cited under Ref.2 that "the feasibility to incorporate such IDA/CDA mapping facility will be examined and will be taken for consideration in future development." Almost six months have passed, and the facility is still not made available in SAMPANN. We are aware that this will be a simple and easy task for the IT team entrusted with SAMPANN Version 2.0. When implemented this will

be of great help for the BSNL absorbed pensioners and will be great relief for the officials in CCA offices.

3. We would therefore request you to kindly bestow your personal attention to the issue and to ensure that the facility is implemented at the earliest.
