**Subject: Request for direct integration of SAMPANN with Jeevan Pramaan for immediate updation of Digital Life Certificates**

Madam,

We hereby draw your kind attention to an important matter concerning the convenience and timely updation of Digital Life Certificates for SAMPANN pensioners.

2. 'Kalanjiyam', a mobile application developed by Government of Tamilnadu and meant for its employee/pensioner management, has been directly integrated with Jeevan Pramaan, enabling pensioners to generate their DLCs seamlessly. The greatest advantage of this integration is that once a DLC is generated through Jeevan Pramaan, it is updated in Kalanjiyam within minutes, ensuring immediate reflection in the pension records. This has brought immense relief to pensioners by eliminating delays and uncertainty.

3. In contrast, BSNL absorbed pensioners who are covered under SAMPANN face avoidable delays. When they generate their DLCs through Jeevan Pramaan using Face Authentication, the updation in SAMPANN takes several days. This waiting period causes anxiety among pensioners and undermines the efficiency of the system.

4. Given the proven success of the Kalanjyam–Jeevan Pramaan linkage, devising a similar mechanism for direct integration of SAMPANN with Jeevan Pramaan will ensure that:
- BSNL absorbed pensioners can generate their DLCs directly from SAMPANN using Jeevan Pramaan.
  - The DLCs thus generated are updated in SAMPANN immediately, without delay.
  - Pensioners are spared the inconvenience of waiting anxiously for days for confirmation of their life certificate status.
5. We therefore request you to kindly take up this matter on priority and initiate steps for direct linkage of SAMPANN with Jeevan Pramaan, in line with the successful model already implemented in Tamil Nadu through Kalanjyam.
