Sub: Stoppage of additional pension on attaining the age of 80 years consequent to migration to SAMPANN – case of Shri N.B.Khamkar, Retd SDE

Sir,

We are constrained to draw your kind attention to the plight of a super senior citizen, who has stopped receiving the 20% additional quantum of pension since November 2023 on migration to SAMPANN and is unable to get the issue resolved despite contacting CCA Maharashtra office several times.

2. Shri N.B.Khamkar, Retd SDE, PPO Number: 402002081208783, was drawing his pension from GPO Indore till October 2023. From November 2023 he is receiving pension from CCA Maharashtra & Goa, due to migration to SAMPANN. This is another case of incorrect mobile number in SAMPANN data and therefore he did not receive any SMS on migration. He is unable to log in to SAMPANN for the same reason. He was receiving additional quantum of 20% of pension on his attaining the age of 80 years. Presently he is 82 years old. Since migration in November 2023, the pension received by him is short of the additional quantum of 20%, again may be due to incorrect data in SAMPANN. Fortunately, his personal details appear correctly, along with the new PPO number, in the Pensioner ID Card issued to him by none other than the CCA Maharashtra & Goa. He has been contacting CCA MH & Goa over

phone and email requesting resolution of the issue but without success. He has been paid Rs.85000 less till this month after migration.

3. We shall be thankful, if you kindly advise the CCA Maharashtra & Goa to get his personal details corrected in SAMPANN, restore the additional quantum of pension and also pay the arrears of short payment since November 2023 at the earliest and thus relieve the super senior citizen of his unwarranted agony.
