Subject: Non-grant of additional quantum of pension on completing the age of 80 – Non-restoration of second portion of commutation from due date - case of Shri Prem Singh Kher, Retd.SDE WTR Indore (PPO No. 402005081208520) by CCA Maharashtra & Goa

Madam,

We would like to draw your kind attention to non-grant of additional quantum of pension on completing the age of 80 and non-restoration of second portion of commutation from the due date in respect of Shri Prem Singh Kher, Retd.SDE WTR Indore (PPO No. 402005081208520) by CCA Maharashtra & Goa, in spite of his repeated representations.

2. Shri Prem Singh Kher, retired as SDE, WTR has completed 80 years of age in August 2025 as his Date of Birth is 08.08.1945, which had been shown correctly in his original PPO. The revised PPO under SAMPANN shows his Date of Birth wrongly as 01.07.1950, being the reason behind non-grant of additional pension w.e.f. 01.08.2025. The correction in his date of birth has not been done despite his representations.

3. Also, the second portion of commuted pension, Rs.69/- was restored from May 2024, although it should have been restored in November 2023.

4. We therefore request you to kindly direct CCA Maharashtra & Goa to immediately grant the additional quantum of pension w.e.f. 01.08.2025, to restore the second portion of the commuted pension due from 10.11.2023 and to refund the excess recovered amount. Copy of the latest representation along with copy of original PPO from the aggrieved pensioner is enclosed.
