Sub: Harassment of SAMPANN Pensioners by the office of CCA Tamilnadu by unwarrantedly recovering TDS even before expiry of deadline for 'proposed investment declaration'.

Sir,

It has been brought to our notice that bulk of BSNL absorbed SAMPANN pensioners under CCA Tamilnadu were in for a rude shock on receiving their pension for the month of May 2023. TDS has been recovered from their pension, although the time-schedule prescribed by the office of CCA Tamilnadu [copy enclosed] itself for submission of option form for Old Tax regime and for 'Proposed investment Declaration' under Old Tax Regime was 31st May 2023. It is a quite uncalled for and reckless action on the part of office of CCA Tamilnadu to recover TDS for the FY 2023-24, even before the deadline has ended.

- 2. More seriously TDS has been recovered even in respect of those pensioners who had duly submitted actual investment declaration along with requisite documents. This happened in the last financial year too. The casual reply the pensioners then got was that they can claim refund from IT authorities. This was seen as adding insult to injury, as these pensioners are waiting for months to get the refund of huge amounts after filing the ITR. Even those who would have remained in default New Tax regime due to their cumulative pension not exceeding Rs.7 lakhs, have not been spared.
- 3. The major concern reported is that in the recent past Tamilnadu CCA office has become difficult to access including at the PRM number, emails are not acknowledged and

complaints raised in SAMPANN are neither responded to nor acted upon. We are really worried that the concerned officials are totally insensitive to the sufferings inflicted on the aged pensioners.

4. We therefore request your immediate intervention and instructions to CCA Tamilnadu for corrective measures and for speedy refund of the TDS recovered, without pushing the pensioners to the ordeal of waiting for one more year for getting refund from Income Tax authorities.

NEW TAX REGIME becomes the default tax regime for all pensioners IT calculation. Thus, unless an individual specifically opts for the OLD TAX REGIME, their income will be taxed at the NEW TAX REGIME's slabs and rates as per rules.

Only OLD TAX REGIME opting pensioners are need to send Option Form, others, no need to send any option form as their IT calculation will be under NEW TAX REGIME only.

The Income Tax is being calculated and deducted based on this office estimated amount of monthly pension payment and arrears/DCRG Int., if any, during Financial Year 2023-24 only.
