Sub: Grievances regarding incorrect personal data in SAMPANN in respect of pensioners who retired from WTR and are being served by CCA MH & Goa

Sir,

We would like to draw your kind attention to the grievances of BSNL pensioners retired from WTR and are being served by CCA Maharashtra & Goa, regarding incorrect entries of personal details in SAMPANN, resulting in non-restoration of commuted value of pension in time in respect of a few of them and inability to log in into SAMPANN portal by the others. Individual representations have been ignored. Details of these grievances were handed over to the CCA Maharashtra & Goa during the Pension Adalat conducted at Kolhapur on 7<sup>th</sup> June 2024 by our CHQ Organising Secretary Shri Rajan Rajopadhye. But these grievances, still remain unresolved, causing unwarranted anxiety and stress to the pensioners concerned. The details of the grievances are listed below:
