Sub: Request for expeditious final decision in the disciplinary case initiated against Shri A. G. Kamalwar, Retired DE, Bhandara (HRMS No. 197506943) under BA Chandrapur of Maharashtra Telecom Circle, BSNL.

Ref: Our letter No.AIBSNLREA/CHQ/2022/52 dated 28th November 2022

Sir,

This is in continuation of our earlier letter cited above wherein we had submitted that Shri A G Kamalwar, (HRMS No 197506943), Retd DE Bhandara of Maharashtra Telecom Circle is an absorbed BSNL Executive who retired on superannuation on 31.12.2009. Since a disciplinary proceeding was contemplated against him, he was placed under suspension as per Sub-rule(1)(a) Rule-30 of BSNL CDA Rules 2006 by CGMT MH Circle Mumbai on 29-12-2009 i.e. just two days ahead of his retirement. As the Departmental proceedings were pending, Shri A G Kamalwar was sanctioned Provisional Pension by the office of CGMT MH Circle Mumbai on 27.01.2010 for 6 months i.e. upto 30.06.2010, which was further ordered to be continued till completion of the proceedings under CCS Pension Rules 1972 Rule No 9(b) by CGMT MH Circle.

2. Subsequently, after a gap of more than 3 years, he was served with a Charge sheet by the disciplinary authority of CGMT MH Circle under Rule-36 of the BSNL CDA Rules-2006 on 18.03.2013. It took another 3 years for the authorities to conclude the enquiry and furnish the Inquiry Report in the case. But though another long spell of 6 years has passed after conclusion of the enquiry and submission of inquiry report, BSNL is yet to take a final decision

in the matter. As a result, his sufferings continue since his pension has not been regularised and other pensionary benefits are not being paid.

3. In response to our letter which was also submitted through grievance portal, DDG (PG) DoT had informed us on 10.01.2023 that "REQUEST HAS BEEN FORWARDED TO CVO BSNL FOR FINAL DECISION IN THE CASE" [copy enclosed]. But to our dismay the final order is yet to be passed in the case, leaving the pensioner to suffer endlessly with mental distress.

4. In view of the above, this Association just requests you to take the final decision in this particular long pending disciplinary case at the earliest and convey the same to all concerned for further action.
