Subject: Request for early commissioning of CGHS Wellness Centre at Bharatpur, Alwar, Rajasthan

Madam,

We invite reference to our letter No. AIBSNLREA/CHQ/2025/12 dated 12th February 2025, regarding the long-pending demand for opening a CGHS Wellness Centre at Bharatpur, Alwar, Rajasthan.

2. We were then informed vide your reply dated **06.03.2025**, that: *"The Hon'ble Health and Family Welfare Minister has granted approval for opening CGHS wellness Centre at Bharatput, Alwar, Rajasthan. The proposal has been sent to Department of Expenditure, Ministry of Finance for getting approval of creation of posts for opening of the said wellness centre."*

3. Even after the lapse of over a year, the issue remains unresolved. Approval for the creation of posts has reportedly already been obtained from the Department of Expenditure. We would therefore request that the matter may kindly be further processed on priority so that the Wellness Centre can be commissioned at the earliest. A large number of Central Government pensioners, BSNL/DoT pensioners, and serving Central Government employees in the region are eagerly awaiting the operationalisation of this facility, which will significantly ease their access to healthcare.

4. We shall be grateful if the commissioning of the Wellness Centre is expedited and early communication is issued in this regard.
