Sub: Non-payment of medical claims for the year 2018-19 and claims without voucher for 2019-20, 2020-21 and 2021-22 - case of Shri Rabindra Nath Bhunia, Retd EE (E), Kharagpur.

Sir,

We are constrained to draw your kind attention to an isolated case of non-payment of medical claims for the year 2018-19 and claims without voucher for 2019-20, 2020-21 and 2021-22 in respect of Shri Rabindra Nath Bhunia, Retd EE (E), Kharagpur, although Corporate Office had released the required funds last year for clearing all pending bills upto 31.03.2022.

2. It has been brought to our notice that the claims, which have been passed on 26.03.2019 & 28.03.2019 by GMT Kharagpur and the claim without voucher for 2019-20, 2020-21 and 2021-22 till 30.06.2021, remain unpaid till today, even after funds were made available. Shri Rabindra Nath Bhunia had surrendered BSNL MRS card and switched over to CGHS on 07.07.2021. It is not known if this has caused some technical issues for effecting his payment for the bills already passed. Shri Rabindra Nath Bhunia has been struggling to get the issue settled for more than a year now. A copy of one of his earliest representations is attached herewith.

3. We shall be thankful, if the concerned authorities are advised to release the payment without further delay and thus render justice to Shri Rabindra Nath Bhunia, as he cannot be held responsible for any technical issues.
