Sub: Non-payment of medical claim without voucher for the financial year 2018-19 – case of Shri Brajendra Singh, Ex. CAO, O/o GMTD, BSNL, Prayagraj, UP East Circle.

Sir,

We hereby draw your kind attention to the matter of non-payment of medical claim without voucher for the financial year 2018-19 in respect of Shri Brajendra Singh, Ex. CAO, O/o GMTD, BSNL, Prayagraj, despite his several representations, including a grievance registered with PMO PG portal.

2. While he has received payment of medical claim without voucher for the period 2017-18 and three quarters pertaining to 2019-20, till his switch over to CGHS, the claim for the period 2018-19 remains pending. The grievance registered by him with PMO PG has been disposed of by Accounts Officer (Claims) stating that "the name of Shri Brajendra Singh was not included in the list approved by the Administration Section." When the claim has been paid for the prior period, i.e in 2017-18 and after the period i.e in 2019-20, it is surprising how it is being claimed that his name was not included in the list approved by Administration Section for making payment for 2018-19. Unless there is a record with the administrative section to show that he had changed his option for 2018-19, there is no justification in not including his name in the list for claim without voucher. The pensioner cannot be penalized for no fault on his part.

3. We therefore request you to kindly advise CGMT UP East Circle to consider the matter and cause payment of his medical claim without voucher for the year 2018-19, in order that the unwarranted mental agony caused to the pensioner is cleared.
