Sub: Implementation of Chennai CAT order directing refund of Rs.72,200/- recovered as excess payment – case of Shri R.Damodaran, Retd SDE Coimbatore.

Sir,

We hereby draw your kind attention to non-implementation of orders of CAT Chennai Bench in OA 310/00635/2019, directing BSNL to refund Rs.72,200/- to the applicant, which was recovered as excess payment, without any show cause.

2. The Tribunal had issued directions to BSNL “to refund the excess amount of Rs.72,200/- within a period of two months from the date of certified copy of the order” (02.02.2024) and “making it very clear that in the event, there is failure on the part of the respondents to refund the excess amount within a stipulated period, the applicant shall be paid interest also at the rate of GPF after expiry of two months till the date of actual payment of the said amount”.

3. The amount is yet to be refunded to Shri R.Damodaran, Retd SDE, Coimbatore, although 21 months have passed since pronouncement of the order by CAT Chennai. It is learnt that CGMT Tamilnadu has been regularly communicating to BSNL Corporate Office on the matter, with the last communication on 23.04.2025 seeking instructions on further course of action to be taken at the earliest, receiving no response.

4. We would therefore request you to kindly bestow your personal attention to the matter

and to direct Personnel Section of BSNL Corporate office to cause implementation of Chennai CAT orders mentioned above and refund of the amount along with interest without further delay. Copy of the Chennai CAT order and the representation from Shri R.Damodaran, Retd SDE, Coimbatore are enclosed.
