Sir,

We would like to bring to your kind notice that this Association had earlier taken up the above issues vide its letter No. AIBSNLREA/CHQ/2020/67 dated 05.08.2020 which was duly registered under CPENGRAMS Grievance Docket No. DOPPW/E/2020/15400. Karnataka Telecom Circle, while disposing of the said grievance docket on 23.12.2020, had stated in the comment section of the Status Report that "The officer retired on 31-12-2010. He has requested for final superannuation pension, release of leave encashment, DCRG & commuted value of pension. At the time of retirement, a CBI court case was pending against him. He has been exonerated by the designated court at Dharwad. To meet the above demands, VC is required. Action for seeking VC is under process. On receipt of VC, all eligible payments will be made" (Copy enclosed). But it is regretted to state that the grievance has not been redressed till this date.

2. It is now reported that Karnataka Telecom Circle, in a mail to Personnel Branch of BSNL Corporate Office at e-mail id agmpers1@gmail.com on 22.12.2020, had sent a "VC Request" in respect of the above-named pensioner. But the same has not been provided till date which is causing further delay in settlement of this long pending case.

In view of the above, it is requested to expedite appropriate action on the 'VC Request' from Karnataka Telecom Circle to pave the way for settlement of this long pending grievance in which the pensioner is still waiting to receive all his superannuation benefits for long 10 years after his retirement from service.

Grievance Description

A representation in regard to issue of final superannuation pension, release of leave encashment, DCRG, Commuted Value of Pension etc for Shri G P Biradar, Retd DE, Bangalore Telecom District (Karnataka Telecom Circle) is attached herewith for early action. The affected pensioner was acquitted, along with others, of all charges by the designated Court at Dharwad on 25.10.2018 and at present no further case is pending against him. His case is similar to the case of another such pensioner Shri S B Mohare, Retd AO, Karnataka Circle, who was also an accused in the same case but was acquitted of charges and for whom BSNL Corporate Office, vide is No. BSNL-CO-PRII/11(12)/1/2020-PERS-II dated 21.07.2020, has already issued Orders allowing him to retire and receive all pensionary benefits. Shri G P Biradar, Retd DE of Karnataka Telecom Circle is also to be granted his final superannuation pension and other pensionary benefits in the same manner.
