Sub: **Grievances of the absorbed BSNL IDA pensioners- Resolution adopted in the All India Conference of AIBSNLREA held at Varanasi on 24th and 25th March, 2026 seeking intervention of Hon'ble Prime Minister of India in "Concern over delayed release of orders for revision of IDA."**

Hon'ble Sir,

In the All India Conference of this Association convened at Varanasi on 24th and 25th March 2026, which witnessed participation by a substantial number of delegates from across the country, the delegates voiced acute dissatisfaction and concern over the continued non-redressal of pensioners' grievances, particularly those affecting BSNL IDA pensioners. The Conference also recorded its serious disquiet over the consistent disregard by the Department of Telecommunications and BSNL of the binding instructions issued by the Department of Pension & Pensioners' Welfare on several matters.

2. In view of the above, the Conference unanimously resolved to approach the Hon'ble Prime Minister of India for timely intervention, as it was felt that the concerned Ministries and Departments have, in numerous cases, been disposing of grievances with routine and unrelated replies instead of addressing the substantive issues involved. The Conference adopted a total of 13 Resolutions covering various matters. We now respectfully submit Resolution No.8 for your kind consideration, which relates to the Department Public Enterprises and concerns the " **Concern over delayed release of orders for revision of IDA**", as detailed in the enclosed resolution, with a request to advise DPE to resolve the issue expeditiously.

CONCERN OVER DELAYED RELEASE OF ORDERS FOR REVISION OF IDA: The All India Conference of AIBSNLREA held at Varanasi on 24th and 25th March 2026 observes with disappointment that the Department of Public Enterprises (DPE) has repeatedly delayed issuing IDA revision orders for almost every quarter during the recent past. Every time there has been a delay, unnecessary doubts and apprehensions arise in the minds of the pensioners about whether the Government is reconsidering or discontinuing the payment of IDA itself. The delay in issuing IDA orders also creates significant administrative complications for the pension drawing CCA offices and results in delayed payment of IDA as arrears. Despite repeated representations to the Secretary, DPE, the delays have persisted, culminating in an unprecedented delay in the IDA increase due from 01.01.2026, forcing this Association to escalate the matter to the Hon'ble Finance Minister. **This Conference strongly urges the Department of Public Enterprises to issue IDA revision orders within the first half of the month in which they fall due, as was the consistent practice for decades.**
