2 It may kindly be seen from the minutes that in the said meeting it was stated that some clarifications on the proposal from Department of Telecommunications were received by Department of Pension & Pensioners' Welfare and the proposal was under examination. It was also decided that the response of Department of Pension & Pensioners' Welfare will be communicated to Department of Telecommunications at the earliest.

3 However, it is regretted to inform you that the issue is still not resolved even though the requested clarifications on the proposal of Department of Telecommunications to resolve the issue were received in Department of Pension & Pensioners' Welfare about two months back. Considering the fact that the issue involves those absorbed BSNL pensioners who retired some thirteen (13) years back and are of above 70 years of age, this genuine grievance of these pensioners may kindly be resolved at the earliest.
