Sub: Non-release of original Land Deed by CGM, QA & Inspection Circle, BSNL to Shri Asit Baran Murmu, Retd DGM, CMTS, Kolkata despite full recovery of the House Building Advance granted to him due to non-furnishing of recovery details for the months from September 2003 to July 2004 by Accounts Officer (Pay), Department of Telecommunication, Sanchar Bhawan

Sir,

We find no alternative but to encroach upon your valuable time on the above issue since our repeated approach to the concerned authorities failed to get the issue resolved. When the concerned pensioner exhausted all the available channels to get back his original land deed from the o/o CGM, Inspection & QA Circle, Jabalpur, this Association had to step in. We took up the matter first with Pay & Accounts Officer (Headquarters), Department of Telecommunications vide our No. AIBSNLREA/CHQ/2018/11 dated 17.02.2018 and thereafter with Member (Finance), Telecom Commission vide our No. AIBSNLREA/CHQ/2018/42 dated 30.08.2018. But the issue remained unresolved.

In this case, the Accounts Officer (sea) of the o/o CGM, Inspection and QA Circle, Jabalpur had been writing letters after letters to the Accounts Officer (Pay) of DOT Headquarters, Sanchar Bhawan to furnish the details of recovery particulars of HBA during the period w.e.f September 2003 to July 2004 in respect of Shri A B Murmu when he was working in DOT Head Quarters during the said period. Copy of one such reminder letter vide No. TD/AG-1202/HBA/ABM dated 11/12/2017 addressed to the Accounts Officer (Pay), Department of Telecommunications, New Delhi by the Accounts Officer (sea), o/o CGM, Inspection & QA Circle, Jabalpur was earlier duly enclosed by this Association with its representation to Member (Finance), Telecom Commission. But there is no response from the Accounts Officer (Pay), DOT Headquarters so far on this issue.

3. In the above background, we earnestly request you to kindly intervene in the matter so that Shri A B Murmu, Retd DGM gets back his original Land Deed at the earliest ending the agony of this pensioner that he is facing for the inaction of Department of Telecommunications for last few years.
