Editorial

LOOKING AHEAD WITH CONFIDENCE...

very year before the Union Budget, expectations run high, stakeholders across various sectors eagerly awaiting some favourable announcements. Common citizens hope for tax benefits and relief from the burden of rising prices. Naturally, Senior Citizens expect special consideration in basic exemption limit, tax slabs, improvements in Senior Citizen Savings Schemes. exemption from income tax for medical benefits availed from ex-employer etc.

milarly, people expect Ifavourable announcements as per their own wish and requirement, before announcement of general elections, on the understanding that announcements cannot be made after notification of elections with the code of conduct kicking in. We are very much aware that BSNL employees were desperately hoping that their pay/wage revision would be announced just before elections. The sudden revival of wage negotiations between BSNL Management and the recognized unions, gave room speculations, expectations and optimism and everything ended as a pipe dream.

t is not that the pensioners did not have any expectations. Those who retired a day prior to the date their annual increment became due were expecting a DoP&T order to be issued before the elections are announced, allowing the benefit of Supreme Court judgements, to

all the similarly placed pensioners, as DoP&T has been talking of an ongoing consultation process for a long time. Ultimately, they feel let down. Some pensioners hoped for an announcement regarding restoration of concession to Senior Citizens by the Railways, which remains wishful thinking. And some overenthusiastic pensioners even wanted that pensioners should be completely exempted from paying income tax, inspired by several WhatsApp messages, ignoring the fact that no Government will agree to this as pensioners continue to substantially contribute to the Government's income by paying Income Tax.

Ithough these expectations have gone unfulfilled, some real issues faced by the pensioners need resolution sooner than later. AIBSNLREA was the first pensioner association to take up the matter of grant of notional increment for pensionary benefits for those who retired a day prior to their date of increment, immediately after the Tamilnadu Government granted this benefit to its employees vide a Gazette Notification on 31.12.2014. Since then, there have been number of CAT judgments favouring grant of notional increment, many High Courts confirming these judgements and the Supreme Court dismissing the appeal by the Government in several cases. The Delhi High Court even ordered "passing of necessary orders not only in respect of the

petitioners but also in respect of all similarly situated persons". Despite several representations from us and other organisations, amid continuing court cases being filed every other day by affected pensioners, DoP&T is still dragging its leg, citing 'consultation process'. In fact, AIBSNLREA CHQ has been receiving calls now and then from affected pensioners belonging to different central government departments and undertakings, enquiring about the status of the issue, which shows the significance of the matter.

The Government is yet to take a decision on the recommendation made by a Departmental Related Parliamentary Standing Committee in its Report 110 regarding enhancement of FMA Rs.1000/- p.m to Rs.3000/- p.m, more than 2 years after submission of the recommendation. As usual, the matter is pending with the Department of Expenditure.

nother recommendation of the Department Related Parliamentary Standing Committee in the same Report, was to grant additional quantum of Pensioners/family Pension the pensioners @ 5%, 10% and 15% on attaining the age of 65 years, 70 years and 75 years respectively. Immediately the DOP&PW called for details of age-wise number of pensioners, amount of pension paid in December 2021 with DR and without DR, for working out the financial implications. Referring to this DOP&PW letter, DoT requested the CGCA, New Delhi to provide the information in respect of telecom pensioners by 07.02.2022. The matter was also discussed in the 32nd Meeting of SCOVA and as per the official minutes of the meeting held in May 2022 "On the issue of **Enhancement of Additional Pension on** attaining age of 65 years, 70 years and 75 years, JS (Pension), DOPPW has informed that the proposal is under consideration in consultation with DoE and DOEA on the aspects of funds availability in the Budget." This had raised high expectations among the pensioners, because availability of funds in the Budget could not be a major hurdle and funds could be allotted anytime.

ut belying all expectations, the Department of Expenditure vide their ID Note dated 01.06.2022 had stated that "the proposal has been examined in that Department and in line with the views offered by Budget Division of DEA considering the fiscal perspective of the Govt., the proposal is not agreed to." The same Parliamentary Committee in its Report 120, shelved the issue observing that "The Committee takes note of the reply and do not wish to pursue this matter for now in wake of the reply of the Department." This, however, leaves space for taking up the issue again in the future.

n this matter, it is important to note that the Government of Himachal Pradesh has been already granting additional pension in the name of pension allowance @5%, 10% and 15% on basic pension/family pension to the State Government pensioners /family pensioners, including AIS pensioners/family pensioners on attaining the age of 65 years, 70 years and 75 years respectively, since the year 2014.

Another important issue relates to restoration of commuted portion of pension in less than 15 years. Orders were issued in 1983, implementing a Supreme Court judgement to restore commuted pension in 15 years, based on calculations which showed that the

commuted amount was recovered in 12 to 13 years. Although the V CPC had recommended restoration in 12 years, the Government did not accept it. AIBSNLREA took up the matter with the Prime Restoration Minister requesting **Commuted Value of Pension after 7 years** from the date of commutation in view of the fact that the interests on loans given by the banks have drastically come down and commuted value of pension gets recovered fully within 7 years. In the Standing Committee meeting of National Council (JCM) the demand for restoration of commuted portion of pension after 12 years was raised and the Official side stated that "The matter has been referred to Ministry of Finance, Department of Expenditure on 03.10.2022." In the recent meeting of the Standing Committee of JCM held in December 2023, the Official side expressed its "desire that the DOP&PW and the Department of Expenditure should hold a meeting with Staff Side and if the issue is not resolved then the same can be raised in the main

meeting of the National Council – JCM". While the Kerala Government has been restoring the commuted portion in 12 years, Gujarat Government has issued orders for restoring in 13 years. Some other State Governments also are reported to have been restoring the commuted amount in less than 15 years.

IBSNLREA is determined to confront these real issues of the pensioners -Notional increment for pensionary benefits to those who had retired a day prior to the date their annual increment became due, Increase in FMA from Rs.1000 to Rs.3000 per month, Grant of additional quantum of pension attaining the age of 60, 65 and 70 years @ 5%, 10% and 15% respectively, and restoration of commutated amount in less than 15 years - once the new members of Lok Sabha take oath, by following them up from their present status, as we believe that all these issues are genuine, justified and achievable. ⊖

Important Developments of the Month



DoP&PW had organised a virtual interactive meeting of Pensioners Associations registered under Pensioners Portal with Secretary (Pension) at short notice, on 21.03.2024. Smt.Ramanjit Kaur, Sr. Consultant, DoP&PW welcomed the around 38 participants. Shri Dhrubajyoti Sengupta, who has taken charge recently as Joint Secretary (PW) made a brief speech on the purpose of the meeting, to discuss especially issues related to CGHS and SCOVA. He assured that in the future such interactions will be regularly held on specified dates. He said that a 100 days programme for DLC and a 5 year plan are on the anvil. He requested suggestions for improvement in the format of Pension Adalats. He informed the participants that DoP&PW is on the job for simplifying the pension rules with specific reference to Family Pension and Rule 37 and integrating different pension rules. It will be a process-oriented approach rather than customeroriented approach, he said. He wanted the pensioners associations to create awareness about the Anubhav Awards, write-up for which will be closed for this year on 31st March 2024. He invited suggestions to be sent to his email regarding revamping of Pensioners Portal. Shri Ravikiran Ubale, who has recently joined as Director (PW) spoke briefly. Dr. Pramod from CGHS was present in the meeting.

Secretary (Pension) Shri V.Srinivas then joined the virtual meeting and expressed gratitude towards the pensioners associations for being extended arm of DoP&PW. A handful of associations then presented their views on CGHS, SCOVA, DLC and integration of Railway Pension Rules with CCS Pension Rules. On the issue of increasing the number of wellness Centres, Secretary (Pension) opined that shortage of Doctors and other staff members was the major hurdle for increasing the wellness centres.

GS AIBSNLREA raised two issues pertaining to CGHS viz. Simplification of the Referral system under CGHS through online – as recommended by the Parliamentary Standing Committee on Health & Family Welfare and issue of guidelines for providing some grace period between surrender of BSNL MRS card and obtaining CGHS card and allowing reimbursement of expenditure under CGHS for indoor treatment during the said grace period as per the existing guidelines for Central Government employees. Secretary (Pension) took note of these and wanted us to make a reference through his email so that they can be taken up with CGHS Directorate. He said next SCOVA meeting will be held after the elections and formation of Government.

♣ The virtual meeting of AIBSNLREA CHQ office bearers was held on 01.03.2024 under the Presidentship of Shri V.Chinnapappiah, President. President welcomed all the participants. GS then read out a condolence message to CHQ Joint Secretary Shri R.S.Sandhu, over the untimely demise of his wife Smt. Devinder Kaur Sandhu on 25.02.2024. Then a detailed review, of the action taken on the previous meeting's decision in respect of holding of meetings by the Branches which had not held any meeting during the last year, was done. Progress made on the efforts by the office bearers was appreciated. Specific targets were fixed

for March 2024. President expressed happiness over the joint functioning of the CHQ office bearers, where everyone took responsibility on organisational matters, without restricting themselves to the functions attributed to their posts. Developments, regarding our court case on 78.2% fitment benefit, in BSNL with the scheduled wage revision committee meeting on 5th March 2024, were discussed. Meeting ended with the President thanking the office bearers for the lively interaction.

Issues taken up

22.03.2024: AIBSNLREA WRITES TO THE SECRETARY, DOT REGARDING GRANT OF HIGHER PAY SCALES FOR THE STAFF BELONGING TO THE ORGANISED ACCOUNTS IN VARIOUS DEPARTMENTS AND REQUESTING HIM TO TAKE UP WITH DOE FOR ISSUE OF COMMON ORDER ALLOWING THE BENEFIT OF HIGHER PAY SCALES ON ACTUAL BASIS W.E.F. 1.1.1996:

Following the PCAT order dated 21st March 2023 that "all the applicants are held to be entitled to the benefit of replacement/upgraded scale of pay on actual basis w.e.f. 01.01.1996 as against 19.02.2003. Pursuant to this they are also held to be entitled to the payment of arrears which would have accrued in their favour from this date" and further observation that "Before parting we would also express a hope that the competent authority shall on its own extend the benefit of upgraded pay scales to all eligible employees w.e.r.01.01.1996 irrespective of the fact whether they have approached an appropriate judicial forum for the same or not, so that unnecessary litigation is avoided", AIBSNLREA had written a letter to DoE on 11.05.2023 requesting issue of a common order. But DoE had forwarded our letter to DoT for necessary action since DoE does not consider representation received directly. Recently Delhi High Court has dismissed the appeal by Union of India against the PCAT order dated 21.03.2023. AIBSNLREA has therefore requested Secretary, DoT to take up the matter with Department of Expenditure for issue of common orders extending the actual benefit of upgraded scale of pay to all the organised accounts cadres w.e.f. 01.01.1996 itself, with consequent arrears, so that the affected employees, now mostly retired, are not forced into an arduous task of seeking legal remedy individually. 14.03.2024: AIBSNLREA AGAIN WRITES TO THE DG CGHS REGARDING EXTENSION OF CGHS TO UDAIPUR CITY:

Drawing attention to DG CGHS Office order dated 10.01.2024, directing the Additional Directors of 10 cities to visit 21 specified locations in their respective jurisdiction and ascertain the feasibility of opening CGHS Wellness Centres at these locations and provide data regarding the likely number of beneficiaries (both serving and Pensioners) in these cities including nearby areas and availability of suitable accommodation, AIBSNLREA has again taken up the issue with DG CGHS, now requesting her to cause inclusion of Udaipur City for visit by AD, CGHS, Jaipur to ascertain the feasibility of opening Wellness Centre and thereby extending CGHS to Udaipur City. 11.03.2024: AIBSNLREA AGAIN WRITES TO THE DIRECTOR (HR) REGARDING RELEASE OF FINAL RETIREMENT ORDERS FOR SHRI B M NYAMATI, CONSEQUENT TO DISMISSAL OF SLP FILED BY BSNL AGAINST QUASHING OF CHARGE SHEET BY CAT BANGALORE AND SUBSEQUENT CONFIRMATION OF CAT ORDER BY KARNATAKA HIGH COURT:

BSNL had been unduly harassing the pensioner who was issued a charge sheet a day before his retirement under BSNL VRS2019. CAT Bangalore had issued orders quashing the chargesheet. On appeal by BSNL, Karnataka High Court heard the case and confirmed the orders of CAT Bangalore. Unexpectedly, BSNL filed SLP in Supreme Court against the orders of Karnataka High Court. The Supreme Court has now dismissed the SLP at the admission stage. AIBSNLREA has written to the Director (HR) BSNL earnestly requesting him to ensure early issue of vigilance clearance for final retirement orders to Shri B M Nyamati, who has been denied his retiral benefits and ex-gratia for more than 4 years now. 04.03.2024: AIBSNLREA WRITES TO THE CGCA, DOT, REGARDING CONTINUING WOES OF BSNL PENSIONERS SERVED BY CCA, MAHARASHTRA & GOA – STOPPAGE OF PENSION OF SHRI B.S.RAJPUT, RETD DE BHOPAL SINCE DECEMBER 2023:

AIBSNLREA has drawn the attention of CGCA, DoT to the Continuing woes of BSNL pensioners served by CCA, Maharashtra & Goa making a specific reference to stoppage of pension of Shri B.S.Rajput, Retd DE Bhopal since December 2023 and has requested action as appropriate so that the office of CCA Maharashtra & Goa is put in order, the apathy of the officials towards grievances of the pensioners is halted forthwith and the pension of Shri B.S.Rajput, Retd DE, Bhopal is paid immediately. Responding to the response by Maharashtra Circle repeating the same contention that "the case was intricate with criminal charges and court orders as opposed to regular superannuation case and therefore interest on late payment of gratuity is denied", AIBSNLREA has now requested the CGMT Maharashtra Circle to re-examine the issue, citing sections from Payment of Gratuity Act 1972 and Supreme Court Judgment in Gangahanume Gowda v. Karnataka Agro Industries Corpn. Ltd., (2003) 3 SCC 40. View the letter
