#### **Editorial**

#### ALL ROADS LEAD TO AIC BHUBANESWAR

On the very first day of July next, all of us shall be at Bhubaneswar to participate in our All India Conference. The two-day Conference will be an unique occasion for all us to stay under a common roof and remember our olden days when we together served both Department of Telecommunications and Bharat Sanchar Nigam Limited. Many of us had no occasion to either meet or even talk for past so many years after our superannuation. We may now remember our olden days once again and have a feeling of nostalgia. Some of us may even get an opportunity to meet our old batch mates of the training centers and many past moments of joy and sorrow again may peep out of our memories. Since we are in an Association of homogenous group and fish of same pond, we are never lost in ocean of heterogeneous group with different thoughts and approach. The bondage of friendship and feeling of oneness among us are much much stronger than others.

The AIC will certainly give us an opportunity to deliberate on the issues which, as pensioners, are important to all of us. Though some chronic problems are still haunting us, our bags are not fully empty as well. There is no doubt that changes in CCS(Pension) Rules, 1972 following

acceptance of VI CPC recommendations by the Government could bring some cheers in us. Notable among those are the method of calculation of pension, enhancement of DCRG, additional pension to the very senior pensioners etc. The absorbed pensioners could also get these benefits implemented w.e.f. 1.1.2006. The VII CPC recommendations may also ensure further improvement in DCRG and pension formulation policy. The Government has rekindled the hope of introducing a pension formulation policy in the line of VII CPC recommendations which is similar to OROP implemented for defence personnel.

When we talk of BSNL specific issues, our woes seem never ending. DOT has not only deceived the pensioners but also the serving employees by issuing a Presidential directive on fitment benefit by merger of 78.2% IDA. It has not only deprived the serving employees of their dues, but also practically robbing the pensioners. Even the faulty proposal to give this benefit to the pensioners still has not reached the finality. The anomaly in fixation of pension of those who retired within 10 months of their absorption, non extending the benefit of deferred option to a section of the absorbed pensioners, non-restoration of medical allowance in lieu of outdoor

treatment are few of the areas which are creating irritation in the mind of the pensioners. The decision of the Government to allow payment of pension by the Government to the MTNL employees by allowing the MTNL executives to retain higher pay scales compared to the one stage lower pay scales granted to the BSNL

Executives w.e.f. 1.10.2000 till the next pay revision has created another anomaly.

The AIC will naturally have an in-depth analysis of all these issues and come up with concrete strategies to handle them. Let us join the AIC and contribute our maximum to make it a grand success.

## **CABINET NOTE ON PENSION REVISION**

It is almost for a fortnight that the final cabinet note proposing revision of pension with fitment benefit by merger of 78.2% DA of the pre-2007 pensioners and those retired after 1.1.2007 but before 10.06.2013, duly approved by MOC&IT and scrutinized by Cabinet Secretariat, is said to be ready for dispatch to Cabinet Secretariat. It is also reported that the file submitted to the senior Officers, after complying with the minor deficiencies as pointed out by the Cabinet Secretariat, did not come back to the concerned Section. Normally, such a long delay in returning the file back rarely happens. That is why lots of speculations are being made. Since it has been repeatedly claimed that there is no major deficiency in processing the Cabinet Note, it is expected that in the coming week Sanchar Bhawan will see flurry of activities to send the Note to the Cabinet Secretariat.

### ISSUES TAKEN UP

AIBSNLREA TAKES UP THE ISSUE OF NON-HOLDING OF PENSION ADALAT AT REGULAR INTERVALS BY THE PR CCAs/CCAs: AIBSNLREA has addressed a letter to Secretary (Telecom) bring to his notice that "the Pension Adalats are not being held on regular basis and no fixed interval to hold the Pension Adalat is being followed. Moreover, the pensioners/family pensioners are not getting timely information about holding of Pension Adalat and to file their grievances. Thus, the very purpose to introduce holding of Pension Adalat is being defeated". The Association has also requested that "The Pr. CCAs/CCAs be advised to arrange holding of Pension Adalat on quarterly basis and give wide publicity about the venue, date and time of holding the Pension Adalat. In addition to the website of the Pr. CCAs/CCAs, the information may be uploaded in the websites of all Telecom Circles and even SSAs falling within the limit of the concerned Pr. AIBSNLREA SENDS AN APPEAL TO THE PRESIDENT OF INDIA ON THE DEFERRED OPTION CASE OF THE GROUP C EMPLOYEES ABSORBED IN BSNL: AIBSNLREA has sent an appeal to President of India, copy of which has been endorsed to Prime Minister, MOC&IT and MOS(PP), on non-extending the benefit of option to retain CDA pay scale till their promotion or retirement whichever is earlier to the concerned pensioners which was offered to the Group C&D employees while inviting option for their absorption in BSNL. The Association has urged that "we seek for your kind intervention in the matter for immediate implementation of the said

offer. This must not have been denied once the absorption has already taken place. We, therefore, make an earnest appeal to you for an early restoration of the said benefit to the affected absorbed Group C Employees so that their pay and pensionary benefits are properly fixed and disbursed". AIBSNLREA WRITES TO SECRETARY (PENSION) ABOUT INACTION OF DOT TO RESTORE THE BENEFIT OF 2<sup>nd</sup> ACP WRONGLY WITHDRAWN FROM SOME SDEs (CIVIL) OF WEST BENGAL CIRCLE: AIBSNLREA has since addressed a letter to Secretary (Pension), DoP&PW about the inaction of Department of Telecommunications on the representation to restore the benefit of 2<sup>nd</sup> ACP granted to some retired Executives of Civil Wing, BSNL, West Bengal Circle. These executives were rightly granted the benefit of 2<sup>nd</sup> ACP in accordance with the rules, but subsequently the benefit was unjustifiably withdrawn. The Association had earlier taken up the issue with Secretary (Telecom), but there seems to be no action to resolve the matter. The Association, it is letter, has mentioned about the difficulties of the pensioners in their advance age to get treatment at the clinics of the doctors, submit claims and pursue for their settlement in BSNL Offices. it was recorded that "DOT was asked to finalise the proposal by 31.10.2015." The Association also mentions that BSNL vide its No. 40-27/2011-Pen(B) dated 13.04.2016 has informed AIBSNLREA that DoT in its letter dated 10/04/2015 had asked all Pr CCAs/CCAs to reconcile pension data with their Pension drawing authorities and Pension Sanctioning/Processing Authorities... . In the said background AIBSNLREA has now requested Secretary (Telecom) to resolve this genuine and long pending grievance of a section of absorbed BSNL pensioners early Posting dated 01.05.2016 in this website may be viewed to read the letter.

## **RESPONSE TO AIBSNLREA'S REPRESENTATIONS**

**BSNL SENDS REMINDER TO WEST BENGAL CIRCLE, KOLKATA REGARDING THE CASE OF WRONG FIXATION OF PAY/PENSION OF ARABINDA CHAUDHURY, RETD EE (CIVIL):** In our posting dated 07.02.2016 in this website, we reported that PGM(BW) had written a letter dated 03.02.2016 to the CGMT, West Bengal Circle requesting to supply the copy of the Circle Office letter No. WB/TA/GE/PF/C(58)/86 dated 13.12.2006 with copy of the representation dated 22.08.2006 of Shri Arabinda Chowdhury and also to furnish detailed comments. Since the Corporate Office did not receive any communication from West Bengal Circle, Kolkata, it has issued a reminder to the CGMT, Kolkata vide its No. PF/Arabinda Choudhury/Rtd EE/M(BW-CPC)/2015 dated 12.5.2016 and also endorsed a copy to AIBSNLREA w.r.t. its letter dated 25.04.2016. MINISTRY OF FINANCE REPLIES TO THE LETTER OF AIBSNLREA ADDRESSED TO PRIME MINISTER OF INDIA REGARDING REDUCTION OF RATES OF INTEREST IN THE SENIOR CITIZEN SAVINGS **SCHEME**: AIBSNLREA had earlier represented to the Hon'ble Prime Minister of India expressing serious concern and deep anguish of the pensioners on the decision of the Government to reduce the rate of interest on deposits in Senior Citizens Saving Scheme. The Association had also appealed to the PM to restore the rate of interest on the deposits under Senior Citizens Savings Scheme. [View posting dated 21.03.2016 in this website to read the letter]. The PMO had also forwarded the said representation to Secretary, Department of Pension & Pensioners' Welfare to take appropriate action on the matter [View posting dated 01/04/2016 in this website to read the PMO letter]. Now Ministry of Finance (Department of Economic Affairs) has replied to our said representation and stated that "high small savings interest rates limit the banking sector's ability to lower deposit rates in response to monetary policy of the Reserve Bank of India" and therefore "by quarterly re-fixing the Small Savings interest rates the transmission of the lower interest rates in the economy has been eased" to help India transition to a lower interest rate economy. It has further been stated in the reply that Government had taken a comprehensive view on the social goals of certain National Small Savings Schemes and the issue raised by the Association "is a policy related issue and the same has been noted." **DOT ENDORSES THE OM DATED 06.04.2016 ISSUED BY DOP&PW ON REVISION OF PENSION OF PRE-2006 PENSIONERS BY DELINKING OF REVISED PENSION FROM QUALIFYING SERVICE OF 33 YEARS:** Department of Telecommunication has since endorsed, vide its No. 40-04/2013-Pen (T) dated 05.05.2016, the OM dated 06.04.2016 issued by Department of Pension & Pensioners' Welfare on revision of pension of pre-2006 pensioners by delinking of revised pension from qualifying service of 33 years. It may be recalled that AIBSNLREA had earlier vide its letter No. AIBSNLREA/CHQ/2016/14 dated 26.04.2016 [view posting dated 27.04.2016 in this website to read this letter] requested DDG (Estt), Department of Telecommunications to expedite its endorsement to Pr CCAs/CCAs and others. The meeting ended with presentation of vote of thanks.

BIMONTHLY GENERAL BODY MEETING OF AIBSNLREA, AKOLA BRANCH HELD: AIBSNLREA Akola (MH) Branch held its Bimonthly General Body meeting on 10<sup>th</sup> May 2016 at 04.30 PM at the residence of Shri S.M. He also informed the members that CHQ is already ready to move court once orders for 78.2% fitment benefit is ordered and implemented to get all the deficiencies removed. He also assured that he would again meet GM (Finance) to settle the pending medical claims. Forty nine members attended the meeting and four new life members also joined the Association. S/Shri Ambika Singh, State Finance Secretary, Radhey Shyam, Organizing Secretary, S P Singh, Branch Secretary, A K Shrivastava, Branch Finance Secretary and others also spoke.

ANNUAL GENERAL BODY MEETING OF AIBSNLREA, GUJARAT STATE BRANCH: Gujarat State Branch of AIBSNLREA held it's AGM on 02.05.2016 at Ahmedabad Medical Association Hall at Ahmedabad. Parmar welcomed all the participants and informed about approval of Cabinet note on the proposal regarding merger of 78.2% for fitment of pension by Minister of Communications & IT. He also informed about the activities of the Association during last six months. The House observed silence in memory of the departed members and family members of the Association. Out of forty four eligible senior Life Members who completed 70 years as on 31.03.2016 with minimum one year membership, twenty two members attended conference and they were honoured with bouquet and shawl. A presentation given by the Cardiac Surgeon of Apollo Hospital Ahmedabad was liked by all members. Secretary, Shri A. B.
