### TENSION GRIPS THE ABSORBED BSNL PENSIONERS

All the absorbed BSNL pensioners must have some agonizing time while preparing to join the festivals of Navaratri and Dussehra, since the fate of two of their long pending genuine cases are still hanging in balance. These issues viz, anomaly in fixation of pension to DOT Employees absorbed in BSNL who retired between 1.10.2000 and 31.07.2001 and merger of 78.2% IDA with basic pension benefit to the absorbed BSNL pensioners are routinely coming up for discussions in the last so many meetings of Standing Committee Of Voluntary Agencies (SCOVA) arranged by Department of Pension & Pensioners' Welfare. The official minutes of these meetings are, as usual, giving only the status reports and not any sign of final break through. Quite naturally, the absorbed BSNL pensioners have reasons to be upset.

The Minutes of the last meeting of SCOVA held on 5<sup>th</sup> September 2014, as released by Department of Pension & Pensioners' Welfare on 25.09.2014, raised both some hopes and despair in the minds of affected absorbed BSNL pensioners. The first issue of removal of anomaly in pension of those who retired between 1.10.2000 and 31.07.2001 remains unresolved for over a decade. These pensioners had their pension fixed on the basis of average of last ten months pay which were drawn partly in CDA and partly in IDA pay scales.

Since the CDA pay was less, the average of last ten months pay was also less for them. As a result, their resultant fixation of pension was also on lower side. Had their pay been only in IDA scale, the present problem would not have arisen at all. This is in fact a case relating to principle for fixation of pension. Therefore in order to remove their hardships, the principle for fixation of pension needs to be changed. Following a recommendation from VI CPC, the Government has changed the principle for fixation of pension. It is now based on last pay drawn. But this new principle was made effective from 1.1.2006. Had the Government allowed this principle to be applied retrospectively or at least for the present case, these affected pensioners would have got the justice. At one point of time, the matter was forcefully presented by AIBSNLREA to the Government. But DoP&PW in consultation with DOE, vide its No. 38/6/10-P&PW(A) dated 11.08.2010, informed AIBSNLREA that the pension of these pre-2006 retirees were fixed correctly and turned down the request to **allow** fixation of pension on last pay drawn. Thereafter, a partial solution to the problem was found out by DOT in consultation with DoP&PW as circulated vide DoT No. 40-10/2005-Pen(T) dated 27.09.2011 for fixing the pension at 50 % of the minimum of the pay scale. Since this could not satisfy the majority, AIBSNLREA presented a proposal to DoT that the CDA

pay drawn prior to 01-10-2000 may notionally be fixed in IDA pay for the purpose of fixation of pension [To read the proposal, view the postings dated 29-11-2012 and 22-12-2012 in AIBSNLREA's website]. DoT agreed to consider the said proposal to notionally convert the pay in CDA scales in IDA pay and allow fixation of pension on the basis of average of last ten months pay. And this is the proposal which is now under consideration of DoP&PW. Unfortunately, DoP&PW has examined the present proposal on "financial implication" angle and had asked for several information from DoT. As seen in the minutes of SCOVA meeting, the information as asked for by DoP&PW are yet to be obtained from BSNL and sent to them implying that there would be further delay in resolving the issue. Moreover, DoP&PW may even consult DOE in the matter. Only silver lining in the minutes of last SCOVA meeting is that DoP&PW has agreed to discuss the matter with DOT to find a solution to the issue. If the authorities really intend to resolve the matter, this issue needs to be considered on the basis of principle and not on financial implication angle.

The other case for revision of pension/family pension of pre-2007 and post 2007 BSNL pensioners who retired between 1.1.2007 and 9.6.2013 by allowing the benefit of merger of 50% DA effectively amounting to 78.2% is also very badly delayed. The proposal, which DoT has mooted and DoP&PW has also concurred, is based on wrong foundation and tends to deprive the concerned absorbed BSNL pensioners of their actual dues. Even if the DoT's proposal gets through at one point of time or the other, some problems will continue to be there

and will have to be taken up at the appropriate forum for further redressal. AIBSNLREA strongly believes that had DoT implemented the DPE's Order to allow effective merger of 78.2% IDA w.e.f. 01.01.2007 i.e. the date on which the revised IDA pay scales were implemented in BSNL, the present problem would not have come at all. This issue is also being discussed in the meetings of SCOVA for last several occasions, but has not reached the finality. According to the Minutes of the last SCOVA meeting held on 05.09.2014, the representative of Department of Expenditure had stated that DOE would send its "comments" within one week to Department of Telecommunications. It is, however, a separate issue that some pensioners' associations had reported at that time that DOE had assured to issue the "Orders" within 7 days. Order on the subject, anyhow, has to be issued only by Department of Telecommunications and not by any other Department. Now the question comes how is that the representative of DOE had said on 5.9.2014 that "comments" would be sent within one week when the same is awaited till this day i.e. almost for a month after the said SCOVA meeting. This case is a classic example of how the inter-ministerial consultations on any proposal moved by any Department takes its own time to reach the finality. Given the state of affairs regarding file movements in Ministries, one can now reasonably expect that the "comments" of DOE may reach DOT anytime from now. But it is difficult to predict what would be DOE's stand on the proposal. **Thus, the woes of the affected absorbed BSNL pensioners seem to be never ending. These affected pensioners are naturally under severe stress and tension.**

## **MINUTES OF THE 25<sup>th</sup> MEETING OF SCOVA**

**ix) SI.No.9 of ATR:- Anomaly in fixation of pension to DoT employees absorbed in BSNL, who retired between 1.10.2000 and 31.7.2001.**

DoT informed that BSNL is collecting the requisite information sought by DoPPW from Corporate Offices of BSNL/MTNL. It was decided that the matter may be discussed in a meeting between DoP&PW and DoT to find a solution to this issue.

**x) SI.No.10 of ATR:- Merger of 78.2% IDA with basic pension benefit to the absorbed BSNL pensioners.**

DoP&PW has already conveyed its ‘no objection’ to the proposal. Department of Expenditure intimated that they will send their comments to DoT within a week.

## MEDIA REPORTS

### **GOVERNMENT FORMS COMMITTEE TO ASSESS THE AMOUNT OF UNCLAIMED DEPOSIT IN PPF AND POST OFFICE SAVINGS SCHEMES AND SUGGEST STEPS FOR THEIR UTILIZATION FOR THE BENEFIT OF SENIOR CITIZENS**

In a welcome move, the Union Finance Minister Shri Arun Jaitley has formed a Committee under Shri H R Khan, Deputy Governor, Reserve Bank of India to assess the amount of unclaimed deposits in PPF and Post Office Savings Schemes and also suggest steps for their utilization for the benefits of Senior Citizens. Other members of the Committee are Secretary, Department of Posts, Joint Secretary (Ministry of Law), Joint Secretary (Budget Division, Ministry of Finance), Deputy Managing Director, State Bank of India and Executive Director, Punjab National Bank. The Committee is to submit its report by 31.12.2014. Here is the report on the issue appearing in the media:

NEW DELHI: Finance Minister Arun Jaitley has set up a committee under RBI Deputy Governor H R Khan to assess the amount of unclaimed deposit in the popular PPF and Post Office saving schemes, and suggest steps for utilisation of funds for the benefit of senior citizens. The Committee, which has been set up in pursuance of the announcement made by the Minister in his Budget speech, will also suggest whether the unclaimed deposit should come to government or be kept in a separate account.

The members of the Committee would include Secretary (Department of Post), Joint Secretary (Law Ministry and Budget Division in Finance Ministry), SBI Deputy MD and PNB Executive Director, a notification said. The committee would suggest procedure to bring unclaimed deposits to a common pool, it said, adding that the panel would submit its report by December 31, 2014.

Jaitley in his Budget speech had said a large amount of money is estimated to be lying as unclaimed amounts with Public Provident Fund (PPF), Post Office, saving schemes. "These are mostly out of investments belonging to the senior citizens and on their demise, remain unclaimed for want of relevant payment instructions. I propose to set up a committee to examine and recommend how this amount can be used to protect and further financial interests of the senior citizens," Jaitley had said.

Although there is no official estimate to ascertain the unclaimed amounts in PPF and small saving schemes, it is believed that the amount could run into hundreds of crores of rupees. In the postal department, an account is declared silent or inoperative when there is no transaction for three years. A PPF is a 15-year investment scheme, which attracts tax exemption. The minimum annual investment in PPF is Rs 500. The Budget has announced hiking the maximum annual investment limit in PPF by Rs 50,000 to Rs 1.5 lakh.
