BSNL AT 25 – A STRATEGIC ASSET IN NEED OF STRUCTURAL REFORM

As BSNL marks its 25th anniversary, it is worth revisiting the vision that led to its formation in October 2000. Carved out of the Department of Telecommunications, BSNL was envisioned as a strategic public sector entity to democratize access to telecom services, especially in rural and underserved regions. Its mandate was clear: provide affordable, reliable connectivity across India, bridge the digital divide, and serve as a backbone for national security and public infrastructure. It was a journey that began with promise.

BSNL had a magnificent start indeed. Though allowed to join the race of mobile services quite late, it successfully established mobile networks nationwide, even in remote areas where private companies were hesitant to venture. For several years, it held the position of the second largest mobile service provider.

Yet today, BSNL stands battered, its market share dwindling to just over 8%, while private giants like Jio and Airtel dominate the landscape. The reasons for this decline are not rooted in lack of capability or intent, but in a persistent pattern of governmental interference and strategic missteps.

The continued deputation of ITS officers in BSNL, without absorption, created a

structural disconnect that undermined the company's operational efficiency and strategic coherence. As decision-making officers remain tethered to their parent government cadre, their accountability and long-term commitment to BSNL's success are diluted. This duality led to misaligned priorities, bureaucratic inertia, and a lack of ownership in driving innovation or responding to market dynamics. This resulted in sluggish decision-making and weakened organizational morale. The recommendation of IIM Ahmedabad that "The Board of Directors should also include professionals who have had experience of running large businesses" was deliberately ignored, while other recommendations were implemented.

BSNL has never been allowed to function as a truly autonomous corporate entity. Strategic decisions, from vendor selection to technology adoption, have been micromanaged by the government, often with political or protectionist motives. BSNL was unable to expand due to government decisions that repeatedly cancelled tenders at crucial moments. This marked the beginning of BSNL's decline.

While private players raced ahead with 4G and now 5G, BSNL was shackled. It was denied timely spectrum

allocation and barred from procuring proven global technologies. Instead, it was mandated to deploy only indigenous 4G solutions, which were still in developmental stages. While the push for Atmanirbhar Bharat is laudable, forcing BSNL to be the sole testbed for unproven indigenous telecom technology has turned it into a guinea pig rather than a competitor. The result - slow rollouts, patchy service, and further loss of consumer trust. This has cost BSNL millions of subscribers and eroded its relevance in urban markets.

The consequences are stark. BSNL has lost over 21 million subscribers in just two years. Its inability to offer 4G services in a market where data consumption is exploding has rendered it obsolete for most urban users. BSNL missed the opportunity to capitalize on customer dissatisfaction when private operators increased their tariffs. Even in rural areas, where BSNL once held sway, private players are making inroads with aggressive pricing and better service quality.

Despite multiple financial bailouts significantly involving non-cash and book adjustments, the core issues, lack of autonomy, outdated procurement norms, and absence of competitive agility remain unaddressed. Ministerial speeches and official statements often tout BSNL's "strategic importance" and "revival plans." But without structural reforms and genuine operational freedom, these proclamations ring hollow. Chest-thumping cannot substitute for competitive strategy.

The denial of pay revision for BSNL employees since 1.1.2017, citing affordability concerns, has had a profound impact on workforce morale. Despite their continued dedication and service, the absence of timely financial recognition has led to widespread dissatisfaction and a sense of neglect among staff, now reduced to just around 35,000 after BSNL VRS 2019. This prolonged stagnation in salary not only undermines motivation but also hampers productivity and organizational loyalty.

If BSNL is to survive and thrive, it needs more than revival plans. It needs liberation. For reclaiming its relevance, BSNL must be allowed to make its own commercial decisions, including vendor selection, technology adoption, and pricing strategies. BSNL should have the freedom to choose the best available technology, domestic or global, to ensure service quality and speed. BSNL Board should have telecom experts, not bureaucrats.

BSNL's survival isn't just about market competition, it's about national security and strength. It is the only operator committed to remote connectivity, reliability during natural calamities, and fulfilling Government obligations. A strong BSNL will ensure that telecom tariffs remain affordable to the common man.

Let us hope that in its 26th year, BSNL is not just celebrated in speeches but empowered in strategy. The common man deserves a telecom provider that is both inclusive and competitive, and BSNL, if truly unshackled, can be just that. ☹



Important Developments of the Month

AGSs AIBSNLREA Shri V.P.Arya and Shri Rakesh Sethi visited BSNL Corporate office on 17.09.2025 and had discussions with officers concerned over the issues we have raised through our letters, and the following is the outcome:

Implementation of CAT orders on stepping up of pay of seniors on par with juniors consequent to upholding of the orders of Chennai CAT by Madras High Court:

We made a mention of the Supreme Court recently dismissing a SLP filed by BSNL against another order of Madras High Court favouring the applicant in a similar case and requested avoiding filing appeals whenever a matter had attained finality. It was agreed the matter will be examined.

Undue delay in issuing promotion orders to Shri M.N.Chavda:

We expressed deep concern over the delay after we were informed a few months back that orders would be issued shortly. We were informed that the delay was due to a technical issue wherein the VC had expired and fresh VC is being awaited from CVO BSNL and that it is being pursued with vigilance for early issue of orders.

Declaring the chargesheets issued to hundreds of VRS retirees of Maharashtra Circle and its jurisdiction null and void:

Detailed discussions were held in line with our letter addressed to CMD BSNL. The officers were convinced about the points raised by us in our letter, but the issue will have to be further discussed with PGM (Estt)/(Admin)/(Rectt.&Training) who was busy in a meeting and hence was not available.

Long pending issue of non-payment of medical claim of Shri R.K.Tandon:

A copy of our letter was left with the PS of PGM (Admin) and the issue will be discussed with PGM (Estt)/(Admin)/(Rectt.&Training) during our next visit.

The monthly virtual meeting of AIBSNLREA CHQ office bearers was held on 03.09.2025 under the Presidentship of Shri V. Chinnappiah, CHQ President. In his opening remarks, the President warmly welcomed the participants and expressed satisfaction over the growing cohesion within CHQ, a result of consistent monthly deliberations. The General Secretary, in his introductory address, shared his deep appreciation for the unwavering dedication of the office bearers. He was particularly moved by the presence of Shri M. Venkateshwar Rao, Vice President, who joined the meeting from outside the hospital ward where his wife is undergoing treatment for cardiac issues. He also recalled how Shri K. Gopinathan, OS (South), had previously attended a meeting from a wheelchair while recovering from an accident, which are testaments to the commitment of the team. To further illustrate this spirit, the General Secretary mentioned the Financial Secretary's eagerness, noting that he had logged in promptly on 1st September, anticipating the meeting as per the usual schedule. The General Secretary then briefed the attendees on key developments during the month, with special emphasis on the meeting with Member (S). He highlighted the encouraging assurance from Member (S) that the pension contribution issue would be resolved within the next few months. Following this, office bearers presented updates on activities in their respective areas. They raised queries on several matters, including notification of the VIII CPC, CPENGRAMS-related concerns, response from CBDT to the association's letter regarding ITAT Chandigarh orders, challenges faced by VRS retirees

in Maharashtra Circle, wage negotiation committee discussions and a few individual cases. The General Secretary addressed these queries and noted that the association is awaiting further action from the Income Tax Department on the ITAT Chandigarh orders. He also outlined the next steps planned to address the Maharashtra issue. It was decided that the AGSs would visit the corporate office next week, followed by another visit to DoT to pursue pending matters. The meeting concluded with the President extending heartfelt thanks to all participants for their active involvement and continued commitment.

Issues taken up

30.09.2025: AIBSNLREA WRITES TO THE SECRETARY, DOT REGARDING INORDINATE DELAY IN APPROVAL FOR PERMANENT ABSORPTION IN BSNL IN RESPECT OF SHRI H.S.SUTARIA, RETD JTO, GUJARAT CIRCLE:

AIBSNLREA has written to Secretary, DoT, expressing shock and concern that the case has not progressed further on the specious plea that high courts, nowadays are not giving relief to the pensioners, implying that the decision in the appeal may go against the pensioner. AIBSNLREA has stressed that it is imperative that the case be processed on extant instructions and precedent, not on imagined outcomes or personal opinions of officials and that justice not be denied by apathy or indifference. AIBSNLREA has requested his personal attention to the issue so that approval for permanent absorption in BSNL is issued without further delay. [View the letter](#)

23.09.2025: AIBSNLREA WRITES TO THE CGCA, DOT REGARDING NON-RESTORATION OF SECOND PORTION OF COMMUTATION IN RESPECT OF SHRI G.N.JATAKIA, RETD SDE WTP:

AIBSNLREA has drawn the attention of CGCA, DOT to non-restoration of second portion of Commutation in respect of Shri G. N. Jatakia, Retd.SDE WTP by CCA Maharashtra & Goa, despite several reminders from the pensioner and has requested her to direct CCA Maharashtra & Goa to immediately restore the second portion of the commuted amount due from 15.04.2025 and to refund the excess recovered amount. 22.09.2025: AIBSNLREA WRITES TO THE SECRETARY, DARPG REQUESTING RECTIFICATION OF SYSTEMIC LACUNA IN CPGRAMS REGARDING CLASSIFICATION OF GRIEVANCES AS SUGGESTIONS:

AIBSNLREA has drawn the attention of Secretary, DAR&PG to a contradictory design in the system which has led to a recurring problem: many Grievance Redressal Officers (GROs) are closing even genuine grievances prematurely by categorizing them as suggestions, thereby bypassing the requirement to file an Action Taken Report (ATR) and excluding the case from the feedback and appeal loop. This loophole is being exploited by certain authorities to avoid addressing genuine grievances. Once a submission is labeled a suggestion, the complainant is left without any recourse to seek redressal, feedback, or appeal. This undermines the very purpose of CPGRAMS and erodes public trust in the grievance redressal mechanism. AIBSNLREA has therefore requested issuance of clear guidelines to all GROs instructing them not to dismiss grievances as suggestions unless they genuinely fall outside the scope of redressal—and to ensure that such cases are still documented and acknowledged appropriately and inclusion of a feedback and appeal mechanism even for cases marked as suggestions, to ensure transparency and accountability. 24.09.2025: GUIDELINES FOR ALLOWING MEDICAL FACILITIES UNDER CGHS/CS(MA) RULES 1944 TO DEPENDENT TRANSGENDER CHILDREN/SIBLINGS IRRESPECTIVE OF AGE:

MoH&FW vide its OM F. No. 2-1/2025-CGHS(HQ)/C&P/EHS(8328809) dated 16.09.2025 has issued guidelines for allowing medical facilities under CGHS/CS(MA) Rules, 1944, to dependent transgender children/siblings irrespective of age, subject to the conditions that the Individual must be wholly dependent and must have a Certificate issued by District Magistrate under the provisions of Transgender Persons (Protection of Rights) Act, 2019. 18.09.2025: DOE ACCORDS SANCTION FOR CREATION OF 88 POSTS FOR THE 22 NEW ALLOPATHIC CGHS WELLNESS CENTRES PROPOSED:

CGHS Directorate has conveyed the sanction of Department of Expenditure for creation of 88 posts for the proposed wellness centres at Bhilai, Durg, Narmadapuram, Bahdurgarh, Rewari, Rohtak, Jamshedpur, Sabarmati, Bharatpur, Alwar, Haldwani, Nainital, Dharmshala, Kangra, Patiala, Udupi, Shivamogga, Warangal, Tirupathi, Navi Mumbai, Hapur and Mangaluru. A few days back, in our editorial titled 'Pension Contribution on existing pay - Light at the end of the tunnel', we had expressed hope of resolution of the long pending issue, which AIBSNLREA has been pursuing for years, all alone. DoT has finally issued orders allowing BSNL to pay pension contribution in respect of its absorbed employees on the basis of existing pay, but only with prospective effect w.e.f. 01.09.2025. If the service unions and associations had pursued the matter since 2009, this result could have been achieved much earlier, with substantial savings for BSNL. Based on the recommendations of a Committee which also studied inputs from Pensioner Associations, including from AIBSNLREA, DoP&PW has issued comprehensive guidelines for evaluating the existing 57 Pensioner Welfare Associations identified/registered by it and also for identifying new PWAs. It also provides criteria for de-registration of a PWA which gets a score of less than 50 as per Score sheet for evaluation of PWAs as mentioned in Para 4-E for a continuous period of two years. 29.09.2025: BSNL RESPONDS TO AIBSNLREA LETTER DATED 01.08.2025 REQUESTING EARLY IMPLEMENTATION OF CAT CHENNAI JUDGMENT, UPHELD BY MADRAS HIGH COURT REGARDING STEPPING UP OF PAY ON PAR WITH JUNIORS:

AIBSNLREA had addressed a letter to PGM Pers, BSNL CO on 01.08.2025 on the subject, pointing out that pursuing an appeal in the Supreme Court would merely be an attempt to delay granting of the benefits to the applicants. Such action would not reflect well on the BSNL administration. Furthermore, BSNL cannot adopt different stances in various court orders on the same matter, as consistency in legal positions is crucial for maintaining
